Executive Order 348 as well as RA 7192 or "Women in Development and Nation Building Act" direct all government agencies in the national and subnational levels including LGUs to set up GAD Focal Points in their respective jurisdictions.

A GAD Focal Point is a mechanism tasked to catalyze, coordinate, provide direction, monitor, and serve as technical adviser for programs/projects on women and gender and development concerns. However, the LGUs can have their own functions applicable to their needs.

In the pursuit of developing guidelines to strengthen the functionality of GAD Focal Points, there is a need to establish a database of such focal points. The data/ information will serve as inputs in determining the kind of interventions for women empowerment and gender equality at the local level. The DILG in coordination with the National Commission on the Role of Filipino Women (NCRFW) shall establish and maintain the database of LGUs GAD Focal points.

In view hereof, you are hereby requested to submit a report on the composition of your GAD Focal Point (see attached forms) to the Bureau of Local Government Development (BLGD) on or before January 28, 2005.

The DILG Regional Directors are likewise directed to coordinate with their respective Local Chief Executives in accordance with this Circular.
