MEMORANDUM CIRCULAR No. 2005 - 37

Subject : CONDUCT OF THE WORKSHOP ON ECO-TOURISM DEVELOPMENT AND DISASTER PREPAREDNESS FOR THE YOUTH: "TAYO NA SA LIGTAS AT MAGANDANG PILIPINAS"

The Sangguniang Kabataan National Federation (SKNF), in collaboration with the National Movement of Young Legislators (NMYL), will conduct a workshop on Eco-Tourism Development and Disaster Preparedness for the Youth, dubbed as "Tayo na sa Ligtas at Magandang Pilipinas", in two (2) different venues and nuances: Casa Pilar in Boracay, Malay, Aklan on May 3-5, 2005, and Baguio City on May 24-26, 2005.

This activity aims to inform and reinforce good citizenship among the youth especially on their significant role in eco-tourism development and disaster preparedness. In the long term, the workshop aims to inspire the youth to conduct research and maintain relevant infrastructure for sustainable disaster preparedness and eco-tourism in their respective communities; and to ensure the effective and efficient discharge of duties and functions by the Green Brigade per E.O. 52, s 1998, and the SK Disaster Coordination and Health Task Force per Article XVIII, Sec. 1(3) of the SK Constitution and By-Laws.

As part of the SKNF's continuing commitment to provide relevant trainings to the Sangguniang Kabataan, the following are encouraged to attend the activity:

- 1. The Vice-Presidents of the City/Municipal SK Federation, as chairmen of the City/Municipal Green Brigade Federations; and
- The 3<sup>rd</sup> SK Kagawad designated as Chairman of the Disaster Coordination and Health Taskforce, to represent the city/municipality, who shall be chosen by the SK City/Municipal Federation President from among the 3<sup>rd</sup> SK Kagawads of the barangays within the city/municipality.

In observance of current austerity measures, target participants shall attend the workshop as follows:

Further, all City/Municipal Mayors, Punong Barangays and SK City/Municipal Federation Presidents are hereby encouraged to allow the abovementioned participants to attend the activity on official time.

In addition, SKNF shall submit a Post Activity and Financial Report to the Office of the Undersecretary for Local Government (OUSLG, DILG) through the National Barangay Operations Office (NBOO), within fifteen (15) days upon termination of the activity.
