Subject : AUTHORITY TO ATTEND THE CROSS EDUCATIONAL  
IMMERSION

The Sangguniang Kabataan National Federation is conducting a series of cross educational immersions throughout the country, which brings participants, composed of SK Chairmen and SK Kagawads, to interact with their respective counterparts in the visited localities.

These immersions are capped by a seminar on the latest government issuances affecting the role of SKs in their respective barangays. Likewise, it looks into possible lines of actions such as reforming and strengthening the SK as relevant institution for local and national development.

The first of its series shall be conducted on 15-22 June 2005 in the cities of Manila, Tagaytay and Baguio, and shall be participated by the SK Chairmen and SK Kagawads of Butuan City.

The travel expenses and registration fee per participant shall be charged against SK funds, subject to its availability and the usual accounting and auditing rules and procedure.

To ensure the success of the activity, the Mayor, Vice Mayor and Punong Barangays of Butuan City are hereby encouraged to allow the SK Officials to attend the activity on official time.

The SKNF shall submit a Post Activity and Financial Report to the Office of the Undersecretary for Local Government (OUSLG, DILG) through the National Barangay Operations Office (NBOO), within fifteen (15) days upon termination of the activity.
