SUBJECT :

CONDUCT OF THE SANGGUNIANG KABATAAN FEDERATION

ELECTIONS AT ALL LEVELS

Chapter 9, Book III of the Local Government Code of 1991 states that there shall be an organization of all the Pederasyon ng mga Sangguniang Kabataan at all levels, which shall elect from among themselves the president, vice president and other officers, as may be necessary.

Likewise, Article XIV of the 2001 Katipunan ng Kabataan and Sangguniang Kabataan Constitution and By-laws directs all SK units throughout the country to be sequentially federated in every political unit, starting from the municipal and city to the provincial and national levels.

Administrative Order No. 267, dated February 18, 1992, provides for the delegation of the exercise of general supervision of the President over the local government units to the Secretary of the Department of the Interior and Local Government (DILG).

In consultation and agreement with the Sangguniang Kabataan National Federation (SKNF) and the National Youth Commission (NYC), the election dates are scheduled as follows:

DATE	LEVEL
December 3, 2010	Municipal , City (Component/Independent
	Component/Highly Urbanized City) Federations
December 10, 2010	Provincial Federations
January 7, 2011	National Federation

The conduct of the ISKOLAR-BOS shall be deferred. Taking its place is the conduct of an orientation/briefing on the SK organizational structure and functions, where applicable; and the responsibilities of Municipal, City, Provincial and National Officers prior to their election on same date.

Representatives of the NYC shall act as official observer during the actual conduct of the federation elections at the local level.

In addition to the provisions of Section 3, Article I of DILG MC No. 2002-123, the DILG may call upon the Philippine National Police (PNP), if the situation warrants, for assistance to ensure the smooth conduct of the Federation Elections.

DILG Memorandum Circular No. 2002-123, dated August 5,2002 re: Implementing Rules and Guidelines for the Conduct of the Sangguniang Kabataan Pederasyon Elections at all levels, as far as it is consistent with this issuance, shall be observed in the conduct of the federation elections at all levels (Copy Attached).

The payment of registration fee of participants is authorized chargeable against their respective SK Funds, subject to the usual accounting and auditing rules and regulations.

All DILG Officers are hereby enjoined to disseminate this Memorandum Circular in their respective area of jurisdiction and extend technical assistance to the SK federation Officials as may be necessary and appropriate.
