MEMORANDUM CIRCULAR

SUBJECT : LEGISLATIVE SUMMIT FOR THE PROTECTION AND
DEVELOPMENT OF CHILDREN

The Vice Mayors League of the Philippines (VMLP) in coordination with the Council for the Welfare of Children (CWC) and the National Barangay Operations Office (NBOO) will hold the Legislative Summit for the Protection and Development of Children on October 24 – 26, 2012 at the Heritage Hotel, Pasay City, with the theme “Bata, Bida Ka! Sa Lokal na Legislatura!”.

The activity shall gather the stakeholders, particularly from the local legislature, to share and learn the situation and issues concerning children. They will confer with the representatives from concerned National Government Agencies, NGOs and International Agencies to identify areas of cooperation or enhance existing cooperation. They will also formulate (legislative) plans and agenda for implementation in all the Sanggunians in the country and devise a system to capacitate the VMLP to monitor the progress of the formulation and adoption of relevant policies and legislative actions for children.




The target participants are (chosen) Vice Mayors, Provincial Board Members, Sangguniang Bayan/Panglungsod members and Sangguniang Bayan/Panglungsod Secretaries.

In this connection, all Local Chief Executives are hereby encouraged to allow their respective Vice Mayors, Provincial Board Members, Sangguniang

Bayan/Panglungsod members and Sangguniang Bayan/Panglungsod Secretaries to attend the above-mentioned summit on official business.

The payment of applicable traveling expenses, and a registration fee in the amount of Twelve Thousand Pesos (PhP12,000.00) per participant, to defray the costs of hotel accommodation, meals and materials may be authorized, chargeable against their respective local funds subject to the usual accounting and auditing rules and regulations, and that it shall not be charged against the 20% Development Fund.

All DILG Regional Directors and Field Officers are hereby directed to cause the dissemination of this Circular to all LCEs concerned.
