TO : ALL PROVINCIAL GOVERNORS, MUNICIPAL MAYORS AND DILG REGIONAL DIRECTORS

SUBJECT : 2012 GENERAL ASSEMBLY OF THE LEAGUE OF MUNICIPALITIES OF THE PHILIPPINES

The League of Municipalities of the Philippines (LMP) will hold their 2012 General Assembly on December 4-6, 2012 at the Manila Hotel, One Rizal Park, Manila, with the theme, *LMP: Layunin ang Matuwid na Pamamahala at Pagkakaisa 2012 and Beyond.*

This year's assembly aims to provide an avenue for Municipal Mayors to discuss: (1) the League's priority programs and projects for 2013, and mechanisms to strengthen partnership with international and national organizations in implementing key development projects; and (2) strategies to foster stronger ties between and among all league members.

One of the highlights of the said activity is the recognition and awarding of Mayor-Champions and Municipal Governments with demonstrated exemplary performance in local governance, and members who are on their last term as Mayors.

In this connection, and upon the request of Mayor Donato D. Marcos, National President, LMP, Municipal Mayors are encouraged to attend the said activity, on official business.

The payment of applicable travelling expenses and registration fee, if any, to defray the costs of hotel accommodation, meals and assembly materials, per participant, may be authorized chargeable against local funds, subject to the availability thereof, and to the usual accounting and auditing requirements and to all pertinent laws, rules and regulations. Provided, that, the traveling expenses and registration fees of local government participants shall not be charged against the 20% component of the Internal Revenue Allotment or from whatever source which may prejudice poverty alleviation efforts.

The LMP National President shall submit to, through the Director of the Bureau of Local Government Supervision, the Secretary of Interior and Local Government, an After-Activity Report within fifteen (15) days after the assembly, guided by the following prescribed format:

- I. Executive Brief;
- II. List of Participants;
- III. Outputs of Technical Sessions;
- IV. Issues and Agreements or Recommendations, if any;
- V. Total Fees Collected and Disbursed; and
- VI. Appendices, if any.


In this light, may we respectfully request for a Memorandum Circular from the DILG enjoining all municipal mayors to attend the 2012 General Assembly.
