MEMORANDUM CIRCULAR

**T O :** ALL PROVINCIAL GOVERNORS, CITY MAYORS, MUNICIPAL MAYORS, THE ARMM REGIONAL GOVERNOR, AND DILG REGIONAL DIRECTORS

**SUBJECT :** 1<sup>ST</sup> NEGOSYO SA BAYAN ENTREPRENEURSHIP SUPPORT AND DEVELOPMENT TRAINING

The Philippine Center for Entrepreneurship (PCE) and the Center for Future Leadership Inc., (CFL), in coordination with the Department of Trade and Industry-Philippine Trade Training Center (DTI-PTTC), will hold the *1<sup>st</sup> Negosyo sa Bayan Entrepreneurship Support and Development Training* on September 16-19, 2015 at the Royal Mandaya Hotel, Davao City, with the theme, *Local Government Units Creating a Nation of Entrepreneurs*.

This said activity aims to train policy and decision-makers at the municipal, city, and provincial levels, on entrepreneurship development at the grassroots, and engage them to provide appropriate support, establish coordinative mechanisms and bridge efforts to significantly realize entrepreneurial communities. It also seeks to inspire and enable local government units to establish their own entrepreneurial ventures and economic enterprises towards financial independence.

In view of the above, all Provincial Governors, City and Municipal Mayors are hereby encouraged to allow: (a) Chairs and Members of the Sanggunians' Committees on *Trade, Industry and Livelihood*, and *Economic Enterprise Development*, (b) Local Economic and Investment Promotion Officers, (c) Local Enterprise Development Officers, (d) Local Cooperative Development Officers, and other LGU officials and employees designated by the Local Chief Executive to participate in the said training on official business. The payment of corresponding travelling expenses and a registration fee of PhP 9,500.00 pesos per participant covering accommodation, meals and conference materials, and other incidental expenses, maybe authorized, chargeable against local funds, subject to the availability thereof and to the usual accounting and auditing rules and regulations. Provided, that said expenses shall not be charged against the 20% Development Fund or from whatever source which may prejudice poverty reduction efforts.
