SUBJECT : ATTENDANCE TO THE ISLAND CONGRESS 2015 OF THE LIGA NG  
MGA BARANGAY SA PILIPINAS (LnB) - MINDANAO CHAPTER

The Liga ng mga Barangay sa Pilipinas (LnB) - Mindanao Chapter (Regions IX, X, XI, XII, XIII and ARMM) will hold its Island Congress 2015 on September 2-4, 2015 at the Bayview Hotel, Roxas Boulevard, Manila, with the theme "Learn, Improve, Govern, Act to Ensure Disaster Resilient Barangays."

The activity aims to encourage unity and participation of barangay officials in responding to calamities and disaster.

In this connection, through the request of Hon. Gerard Hilarion M. Ramiro, LnB-Vice President for Mindanao, all Regional/Provincial/City/Municipal LnB Chapter Presidents, Barangay Officials and Members in Regions IX, X, XI, XII, XIII and ARMM, are hereby encouraged to participate in the said activity on official business. The payment of applicable travelling expenses and a registration fee per participant, to defray the costs of hotel accommodation, meals and congress materials, may be authorized chargeable against their respective local funds, subject to the availability thereof, and to the usual accounting and auditing requirements and to all pertinent laws, rules and regulations. Provided, however, that the travelling expenses and registration fee shall not be charged against the 20% component of the Internal Revenue Allotment or from whatever source which may prejudice poverty reduction efforts.

The LnB-Vice President for Mindanao shall submit a post-activity report to the Undersigned, through the National Barangay Operations Office, within one (1) month after the conduct of the said assembly.

All DILG Regional Directors and Field Officers in Regions IX, X, XI, XII, XIII and ARMM are likewise directed to cause the dissemination of this Circular in their respective jurisdiction.
