
The Cagayan de Oro River Basin Management Council (CDORMC) and the City Government of Cagayan de Oro, in collaboration with the League of Cities of the Philippines (LCP) and DENR-River Basin Control Office, will host the **Third International River Summit**, to be held on November 24 to 26, 2016 at the Limketkai Luxe Hotel, Cagayan de Oro City, with this year's theme, *"Healthy Watershed: Clean Rivers, Safer Communities."*

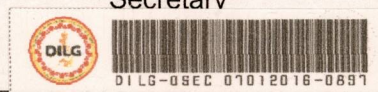
The Summit enjoins the most important stakeholders – the global, national and local authorities, policy experts, river managers from public and private sectors, the academe, leaders in clean water technology, advocates and students – in facing the development challenges of our world's rivers today. It aims to: (a) foster information and knowledge exchanges on the latest technology and approaches on river basin governance from the different participating countries, and (b) discuss issues and concerns on river basin governance, share innovative solutions, and synergize strategies to pursue improved river management programs.

In this connection, all Provincial Governors, City Mayors and Municipal Mayors are enjoined to allow their respective Local Environment and Natural Resources Officers, or the designated river administrator, if any, to participate in the said Summit. The payment of registration fee and travelling expenses to be incurred may be charged against local funds, subject to the usual accounting and auditing rules and regulations.
