ATTENDANCE TO THE 2016 LUZON ISLAND CONGRESS OF THE

LIGA NG MGA BARANGAY SA PILIPINAS (LnB)

The Liga ng mga Barangay sa Pilipinas (LnB) – Luzon Chapter (Regions I, II, III, IV-A, IV-B, V, CAR and NCR) will hold its  $2^{nd}$  Luzon Congress on March 17-19, 2016 at the Newport Arts Theatre, Resorts World Manila, Pasay City with the theme "Ang Marangal na Gobyerno ang Susi sa Matiwasay na Pamumuhay ng mga Kabarangay"

In this connection, through the request of Hon. Vicente G. Pagurayan, LnB President for Luzon Chapter, all Regional/Provincial/City/Municipal LnB Chapter Presidents, Barangay Officials and Members in Regions I, II, III, IV-A, IV-B, V, CAR and NCR are hereby encouraged to participate in the said activity on official business. The payment of applicable travelling expenses and a registration fee per participant, to defray the costs of hotel accommodation, meals and congress materials, may be authorized chargeable against their respective local funds, subject to the availability thereof, and to the usual accounting and auditing requirements and to all pertinent laws, rules and regulations. Provided, however, that the travelling expenses and registration fee shall not be charged against the 20% component of the Internal Revenue Allotment or from whatever source which may prejudice poverty reduction efforts.

The LnB - President for Luzon shall submit a post-activity report to the Undersigned, through the National Barangay Operations Office, within one (1) month after the conduct of the said Congress.

All DILG Regional Directors and Field Officers in Regions I, II, III, IV-A, IV-B, V, CAR and NCR are likewise directed to cause the dissemination of this Circular in their respective jurisdiction.
