In view of the above, all City Mayors and Municipal Mayors are hereby encouraged to allow the attendance of their Vice Mayors to the said provincial chapter and regional assembly elections, on official business. The payment of travelling expenses and corresponding registration fee, the amount of which is to be determined by the VMLP local chapter in coordination with VMLP National Office and with the approval of the concerned DILG Provincial and Regional Directors, to defray the costs of hotel accommodation, meals, kit and other activity-related materials, per participant, may be authorized, chargeable against local government funds, subject to the availability thereof, and to the usual accounting and auditing requirements, and to all pertinent laws, rules and regulations.

Likewise, the payment of a Term Membership Fee of Ten Thousand Pesos (PhP 10,000.00) will be collected from league members pursuant to Section 2, Article V of the VMLP's Constitution and By-Laws.

The VMLP National President shall submit to, through the Director of the Bureau of Local Government Supervision, the Secretary of Interior and Local Government, a Post-Election Report within fifteen (15) days after the said provincial and regional elections have been completed.
