**MEMORANDUM CIRCULAR**

**TO :** ALL PROVINCIAL GOVERNORS AND VICE GOVERNORS, CITY AND MUNICIPAL MAYORS AND VICE MAYORS, REGIONAL GOVERNOR OF THE AUTONOMOUS REGION IN MUSLIM MINDANAO, DILG REGIONAL DIRECTORS, AND OTHERS CONCERNED

**SUBJECT :** 3<sup>RD</sup> NEGOSYO SA BAYAN ENTREPRENEURSHIP SUPPORT AND DEVELOPMENT TRAINING

The Department of Trade and Industry-Philippine Trade Training Center (DTI-PTTC), the Philippine Center for Entrepreneurship-Go Negosyo (POE-Go Negosyo) and the Center for Future Leadership, Inc. (CFL) will hold the **3<sup>rd</sup> Negosyo sa Bayan Entrepreneurship Support and Development Training**, an annual national training designed to encourage and institutionalize entrepreneurial mentorship, innovation and collaboration in the grassroots level. The training will be held on **October 25-28, 2017**, at the **Subic Bay Travelers Hotel and Event Center, Subic Bay Freeport Zone, Olongapo City**.

With the theme “**Developing More MSMEs Thru Mentorship, Innovation and Collaboration**”, the goal of the training is to equip policy and decision-makers in the barangay, municipal, city and provincial levels with significant knowledge and skills to properly assist, support and provide strategic directions to would-be entrepreneurs and start-ups in the barangays and local communities. Further, it aims to provide participants guidance on how local government units (LGUs) may be able to advance its own entrepreneurial ventures or strengthen its existing economic enterprise towards financial independence.

In view of the above, all Governors, Vice Governors, Mayors and Vice Mayors are hereby enjoined to allow the concerned officials from various local government units in the city, municipal, and provincial level to participate in the said event:

- a. Local Economic Investment Promotion Officers, Local Enterprise Development Officers, and Local Cooperative Development Officers;
- b. Chairs and Members of the Local Finance Committee;


- c. Chairs and Members of the Sanggunian's Committees on Trade, Industry and Livelihood, and Economic Enterprise and Entrepreneurship Development; and
- d. Other key LGU officials or employees authorized by the Local Chief Executives, and Liga ng mga Barangay officials.

The officials may participate on official business, provided that it is within the Capability Development Agenda of the LGU, and provided further that any expense of a participant shall not be charged against the 20% Development Fund or from whatever source which may prejudice poverty reduction efforts. The payment of corresponding travelling expenses, registration fee per participant to cover accommodation, meals and conference materials, and other incidental expenses, may be authorized, chargeable to local funds, subject to the availability thereof and the usual accounting and auditing rules.
