MEMORANDUM CIRCULAR

TO : PROVINCIAL GOVERNORS OF REGIONS I, II, III, IV-A, IV-B, V, CAR AND NCR, DILG REGIONAL DIRECTORS AND OTHERS CONCERNED

SUBJECT : 12TH LUZON ISLAND CONFERENCE OF THE PROVINCIAL BOARD MEMBERS LEAGUE OF THE PHILIPPINES (PBMLP)

The Provincial Board Members League of the Philippines (PBMLP) will conduct its 12th Luzon Island Conference on February 23-25, 2018 at the Hue Hotel, Puerto Princesa City with the theme: Exploring Complementary PLBMLP Roles in the Country's Build Build Build Program Strategy."

The following objectives are set to carry out the theme of the conference: (a) review PBMLP's thrusts, programs and projects as a National League of Provincial Legislators; (b) revisit various aspects of provincial legislation to help support the multi-local policy dimensions of program implementation and sustainability; (c) explore the possibilities of helping the national government in the BBB program; and (d) provide updates on the current DILG policies and programs concerning local government leagues.


In view of the above, and upon the request of Hon. Felix F. Ylagan, Vice-President for Luzon, PBMLP, all Provincial Governors are encouraged to allow the participation of their Provincial Board Members in the above-mentioned activity, on official business.

The payment of applicable travelling expenses and registration fee, if any, to cover the cost of hotel accommodation, meals and conference materials, per participant, may be authorized in accordance with the provisions of COA Circular No. 2012-003 dated October 29, 2012 providing for guidelines for the prevention and disallowance of irregular, unnecessary, excessive, extravagant and unconscionable expenses, and chargeable against available local funds and to the usual accounting and auditing requirements, and to all pertinent laws, and rules and regulations.

The PBMLP National President shall submit to, through the Director of the Bureau of Local Government Supervision, the Secretary of the Interior and Local Government, an After-Activity Report within fifteen (15) days after the congress has been conducted, with the prescribed format:

- I. Executive Brief;
- II. List of Participants;
- III. Output of Technical Sessions;
- IV. Issues and Agreements or Recommendations (if any);
- V. Total Fees Collected and Disbursed (if any); and
- VI. Appendices (if any).
