MEMORANDUM CIRCULAR

FOR : PROVINCIAL GOVERNORS, CITY AND MUNICIPAL MAYORS, LIGA NG MGA BARANGAY PROVINCIAL / CITY / MUNICIPAL CHAPTER PRESIDENTS, DILG REGIONAL DIRECTORS OF REGIONS IX, X, XI, XII, CARAGA, ARMM DILG REGIONAL SECRETARY AND ALL OTHERS CONCERNED

SUBJECT : FORUM ON REPUBLIC ACT NO. 11054 OR THE BANGSAMORO ORGANIC LAW (BOL) FOR PUNONG BARANGAYS IN REGIONS IX, X, XI, XII, CARAGA AND ARMM

The Liga ng mga Barangay sa Pilipinas (LnB) – Mindanao Chapter (Regions IX, X, XI, XII, CARAGA and ARMM) will hold a Forum on RA 11054 on August 25 to 27, 2018 at the SMX Convention Center, Seashell Lane, Mall of Asia Complex, Pasay City. It aims to 1) impart among Barangay Chairmen in Mindanao the highlights of the BOL; 2) deepen their understanding on the Mindanao peace process; and, 3) discuss the roles of the local government units in the future Bangsamoro.

In this connection, through the request of Hon. Gerard Hilarion M. Ramiro, LnB-Vice President for Mindanao, OPAPP Secretary Jesus G. Dureza, and with the favorable endorsement by the LnB National President Atty. Edmund R. Abesamis, all Punong Barangays of Regions IX, X, XI, XII, CARAGA and ARMM, are hereby encouraged to participate in the said activity on official business. The payment of applicable travelling expenses and a registration fee per participant, to defray the costs of hotel accommodation, meals and congress materials, may be authorized chargeable against the barangay funds, subject to the availability hereof, and to the usual accounting and auditing requirements and to all pertinent laws, rules and regulations. Provided, however, that the travelling expenses and registration fee shall not be charged against the 20% component of the Internal Revenue Allotment or from whatever source which may prejudice poverty reduction efforts.


