MEMORANDUM CIRCULAR

TO: LOCAL CHIEF EXECUTIVES OF PROVINCE OF BATAAN AND CITIES OF VALENZUELA, NAGA, IRIGA, ILOILO, ORMOC, ZAMBOANGA AND CAGAYAN DE ORO

SUBJECT: ENJOINING PARTICIPATION OF THE LOCAL DISASTER RISK REDUCTION AND MANAGEMENT OFFICER IN THE TRAINING OF TRAINERS ON LEADERSHIP AND GOVERNANCE AND SCIENCE AND TECHNOLOGY PROGRAM

One of the essential components of the project of the National Resilience Council (NRC) in building local resilience is to engage and enable academic institutions in providing training and coaching to the Resiliency Team of their pilot local government units (LGUs). On the other hand, the role of the LDRRMOs is to facilitate, in coordination with their Lead Focal Person/Chief Resilience Officer, the planning and conduct of the capacity building activities by the academic partners in their respective LGUs.

In this regard, the NRC will be conducting a 4-day Training of Trainers on Leadership and Governance, and Science and Technology Program on August 28-31, 2018 in Metro Manila. The 4-day activity will entail an overview of the NRC-CCAR2 Resilient LGU Systems Program. It will also include discussions and agreements on roles and responsibilities of LGUs and an introduction to the modules of Leadership and Governance, and Science and Technology Tracks of the CCAR program.

To maximize its desired objectives, all LCEs of the above-mentioned LGUs are enjoined to ensure the participation of their LDRRMOs to this activity. Travel and accommodation expenses shall be charged against the Local DRRM Fund of each LGU.
