**MEMORANDUM CIRCULAR**

DILG REGIONAL DIRECTORS OF REGIONS III, IV-A, MIMAROPA

**SUBJECT: ATTENDANCE TO THE WORKSHOP ON COMMUNITY-BASED DRUG  
REHABILITATION PROGRAM (CBDRP)**

The Department of the Interior and Local Government issued Memorandum Circular No. 2018-125 entitled "Guidelines for the Implementation of Community-Based Drug Rehabilitation Program" last 08 August 2018. Said Memorandum Circular aims to provide guidance and establish the minimum set of necessary interventions and processes under the Community-Based Drug Rehabilitation Program (CBDRP) to be implemented at the local level.

Thus, the Department, through the Anti-Drug Abuse Council – Project Management Office (ADAC-PMO), shall be conducting an initial workshop on CBDRP which aims to capacitate local government units (LGUs) in developing and/or enhancing their respective community-based rehabilitation programs. Participants to this pilot activity shall be local government units from Regions III, IV-A, MIMAROPA and NCR. This activity shall be conducted in collaboration with the Dangerous Drugs Board (DDB), Department of Health (DOH), and Department of Social Welfare and Development (DSWD). Invited speakers will include representatives of LGUs, faith-based organizations and civil society organizations who will present their experiences and best practices in the implementation of their existing community-based rehabilitation programs. The workshop shall be held on **November 28-29, 2018** at **The Heritage Hotel**, Roxas Boulevard corner EDSA, Pasay, Metro Manila.

In this connection, all Provincial Governors, City and Municipal Mayors are encouraged to send their respective ADAC representative/s, maximum of three (3) per LGU, to attend the said workshop. Due to the limited number of slots available, only the first three hundred fifty (350) confirmed participants shall be accommodated. Please be advised that transportation arrangements and expenses shall be covered by the participants' respective offices while hotel and food arrangements shall be shouldered by the Department.
