SUBJECT: ATTENDANCE TO THE LIGA NG MGA BARANGAY SA

PILIPINAS (LNB) 1ST NATIONAL ASSEMBLY

The Liga ng mga Barangay sa Pilipinas (LnB) will hold its 1st National Assembly at the SMX Convention Center, Manila on February 25 to 27, 2019 with the theme, "1Barangay: Matuwid na Pamamaraan Tungo sa Isang Tunay na Pagbabago."

The objective of the activity is to undertake changes in the direction and management of the National Liga in order to effect better welfare for the barangays and its leaders.

In this connection, through the request of Hon. Faustino "Inno" A. Dy V, LnB National President, all Regional/Provincial/City/Municipal LnB Presidents, Punong Barangays, Sanggunian Kabataan Chairmen and other Barangay Officials, are hereby encouraged to participate in the said activity, on official business. The payment of applicable travelling expenses and a registration fee per participant, to defray the costs of hotel accommodation, meals and congress materials, may be authorized, chargeable against their respective local funds, subject to the availability thereof, and to the usual accounting and auditing requirements and to all pertinent laws, rules and regulations. Provided, however, that the travelling expenses and registration fee shall not be charged against the 20% component of the Internal Revenue Allotment or from whatever source which may prejudice poverty reduction efforts.

The LnB-National President shall submit within one (1) month after the conduct of the Assembly, a Post-activity Report to the Undersigned, through the National Barangay Operations Office, reflecting the following:

- 1. Name of Activity
- 2. Date of Activity
- 3. Venue of Activity
- 4. No. of Pax
- 5. Objectives of the Activity
- 6. Highlights of the Activity
- 7. Output/s of the Activity
- 8. Attachments, if any.

All DILG Regional Directors and Field Officers are likewise enjoined to cause the widest dissemination of this Circular in their respective jurisdiction.
