MEMORANDUM CIRCULAR

TO : ALL PROVINCIAL GOVERNORS, CITY MAYORS, MUNICIPAL MAYORS, DILG-ARMM REGIONAL SECRETARY, DILG REGIONAL DIRECTORS, AND OTHERS CONCERNED

SUBJECT : NATIONAL TECHNICAL OFFICIAL (NTO) COURSE SEPAKTAKRAW FOR PROSPECTIVE NATIONAL REFEREES, TO BE HELD ON APRIL 15-17, 2019 AT THE CEBU NORMAL UNIVERSITY, CEBU CITY

A **National Technical Official Course** for Sepaktakraw Referees will be held on April 15-17, 2019, at the Nursing Hall, Cebu Normal University, Cebu City.

For local referees to be given access and equal chances to be chosen in the Asian referee/International Referee Licensing and serve in the Southeast Asian Games, all Local Chief Executives are encouraged to allow Sepaktakraw Referees within their respective localities, to participate in the said course.


The following are some of the pre-requisites for participating in the said course:

- a. Level 3 (with invitation) and Level 4 of DepED Licensed Referees,
- b. Maximum of two (2) referees endorsed by a SUC, PRISAA or ALCUAA, and
- c. Only one (1) referee endorsed by a City or Provincial Sports Coordinator.

Per criteria for participation, five (5) examinations shall be administered, to include two (2) theories and three (3) practice types of examinations. Only those in the Top 65 can attend the AR/IR Licensing in May, 2019. The payment of registration fee in the amount of PHP 3,500.00 per participant (to include accommodation and lunch) may be authorized chargeable against local government funds, subject to the availability of funds, and to the usual accounting and auditing rules and regulations. Registration fees shall be paid in cash to the Cebu Normal University.
