PILIPINAS (LNB) 3RD VISAYAS BARANGAY CONGRESS

The Liga ng mga Barangay sa Pilipinas (LnB) – Visayas Chapter (Regions VI,VII,VIII) will hold its 3rd Visayas Barangay Congress at the International Eucharist Center, Cebu City on April 2 to 4, 2019 with the theme, "1Barangay: Matuwid na Pamamaraan Tungo sa Isang Tunay na Pagbabago."

Provided, however, that the travelling expenses and registration fee shall not be charged against the 20% component of the Internal Revenue Allotment or from whatever source which may prejudice poverty reduction efforts.

The LnB-Vice President for Visayas shall submit within one (1) month after the conduct of the Congress, a Post-activity Report to the Undersigned, through the National Barangay Operations Office, reflecting the following:
