RESOLUTION NO. 2020-006 September 4, 2020

RESOLUTION CONCURRING THE LOCALIZED LOCKDOWN IN SELECTED AREAS OF THE MUNICIPALITIES OF ALABEL, MIDSAYAP AND TUPI OF THIS REGION

WHEREAS, DILG Advisory dated June 22, 2020 which supports the IATF and NTF Memorandum Circular on the Application of the Zoning Containment Strategy for COVID-19 provides that LGUs, through their Local Chief Executives, have the authority to determine and declare zoning classification and lockdown depending on preset parameters, including the existence of suspected, probable, or confirmed COVID-19 case. The authority maybe exercised immediately to ensure timely response, subject to the review and assessment of the RIATF;

WHEREAS, Per IATF guidelines, LGUs declaring localized lockdowns shall submit to the RIATF thru the Screening and Validation Committee, their data analytics on lockdowns, as reference by the RIATF in concurring the request of the LGUs;

WHEREAS, all activities or interventions in the type of community quarantine shall be in accordance with the Omnibus Guidelines on the Implementation of Community Quarantine in the Philippines issued by the IATF and policies and guidelines issued by the NTF;

WHEREAS, on September 5, 2020, there are 3 municipalities in Region 12, which requested the concurrence of the RIATF-EID XII for a "localized lockdown" namely: the Municipalities of Alabel, Sarangani Province, Midsayap, Province of Cotabato, and Tupi, South Cotabato Province;

WHEREAS, recently, the Municipality of Alabel, Province of Sarangani, Municipality of Tupi, Province of South Cotabato, and Municipality of Midsayap, Province of Cotabato recorded new active cases – 1, 2 and 5, respectively. These individuals were found to be mobile, had closecontacts to other confirmed cases, and with travel history to high risks areas prior to the onset of symptoms or illness and release of RT-PCR result.

WHEREAS, the Screening and Validation Committee of the RIATF convened on September 4, 2020 to assess and validate the requests of the three (3) LGUs pursuant to RIATF-RTF Resolution No. 26-G and recommended for the concurrence of the Declarations for localized lockdown of the LGUs Alabel, Tupi and Midsayap;

NOW, THEREFORE, BE IT RESOLVED, as it is hereby resolved, that the RIATF-EID XII approved RESOLUTION CONCURRING THE LOCALIZED LOCKDOWN IN SELECTED AREAS OF THE MUNICIPALITIES OF ALABEL, MIDSAYAP AND TUPI OF THIS REGION with the following specifications:

A. Localized Lockdown of Alabel, Sarangani on **September 3-17, 2020**, to cover the following areas:

- Wet Section of the Mega Public Market, Alabel
- Purok Tagumpay, Poblacion; and
- Navarro Street, Purok 9 (Sta. Cruz), Poblacion, Alabel
- B. Localized Lockdown of Midsayap, Province of Cotabato on **September 3-17**, **2020**, to cover the following areas:
 - Residential Compounds in Barangay Poblacion 1 and 6
 - Selected Business Establishments located at Public Market (Bagsakan), Poblacion 5
 - Old Public Market owned by the Positive No. 7
- C. Localized Lockdown of Tupi, South Cotabato on September 3-10, 2020, to cover the following areas:
 - Purok 11-A, Barangay Poblacion
 - Purok 3, Barangay Bololmala
 - Purok Malipayon, Barangay Lunen
 - Purok Pag-asa II and Purok Small Spring III, Barangay Cebuano

RESOLVED FURTHER, that a regular reassessment on the parameters shall be conducted every seven days or more frequently, as bases for extension or early lifting of the localized lockdown or zoning containment strategy; and that a map of the Zoning Classifications (Critical, Containment and Buffer Zones) of the above-stated LGUs and data on Close Contacts be provided to RTF-MEID XII on CoVID-19;

RESOLVED FURTHERMORE, that a copy of this Resolution be forwarded to the Provincial Governors, and Municipal Mayors concerned for their information and appropriate action. The same copy to be furnished to the members of the RIATF-EID XII & RTF COVID-19 for their information and prompt action.
