RESOLUTION NO. 003-2020

ADDITIONAL POLICY GUIDELINES AND RECOMMENDATIONS RELATIVE TO THE MANAGEMENT OF CORONAVIRUS DISEASE (COVID-19) SITUATION IN REGION 12

- WHEREAS, the letters of the appeals of the LCEs for the retention of their respective LGUs status to GCQ revealed the following: there were only 1,500 Rapid Test Kits distributed per province and HUC GenSan which is not enough to cover the whole of Region 12; Cotabato Regional Medical Center (CRMC) can only cater 72 tests per day with 7 days waiting period prior to release of RT-PCR test result. It also caters to Region 12 and BARMM, according to DOH-CHD XII; Dr. Arturo P. Pingoy Medical Center (DAPPMC) is still on Stage 3 of its accreditation process and the GeneXpert Diagnostic Machine is scheduled to be delivered sometime next week as committed by BCDA Usec. Vivencio Dizon while DAPPMC Medical Personnel will still undergo proficiency training prior to the full operation of the DAPPMC Testing Facility for a couple of days/weeks; Contact Tracing Systems (StaySafe.ph System and South Cotabato Covid-19 Contact Tracing System -SCCCT) is not fully in-place; Proximity to Maguindanao Province, which is a land-locked province inside Region 12 where there have been 12 additional COVID-19 cases; and influx of Returning Overseas Filipinos (ROFs) and Locally Stranded Individuals (LSIs) from across the country to the Region are among the threats to possible resurge of cases in the Region;
- WHEREAS, Executive Order No. 114 re: Institutionalizing the Balik Probinsya Bagong Pag-Asa Program aims to provide hope for a better future to Filipinos through equity in resources throughout the country that will boost countryside development;
- WHEREAS, NTF Against COVID-19 Order No. 2020-02 provides for the Operational Guidelines on the Management of Locally Stranded Individuals (LSIs) and DILG MC No. 2020-087 provides for duties and responsibilities of the local

government officials, DILG Regional Directors and Field Officers, PNP and others concerned for the Management of ROFs and LSIs;

- WHEREAS, RDC Resolution No. 01 s. 2020 was issued to enjoin all LGUs up to the Barangay level, and all Regional Line Agencies and Other Government Instrumentalities in Region XII to Register and use the StaySafe.ph System Application and other LGU-Initiated Contact Tracing Applications for the Management of Coronavirus in the Region;
- WHEREAS, RTF Economy Cluster Resolution No. 09 s. 2020 enjoins the LGUs to undertake Rapid Anti-Body Based Testing (RAT) as a Complementary Measure in Targeting Individuals for Confirmatory Test through Reverse Transcription Polymerase Chain Reaction (RT-PCR), and Requesting the Private Sector and Concerned Entities to support the same;
- WHEREAS, during the Meeting, the POPCOM RD Edwin Mateo P. Quijano 12 presented the Demographic Vulnerability Report of Region 12 as a result of the COVID-19 pandemic and requested that such be adopted by the Task Force;
- WHEREAS, on May 26, 2020, the General Santos City Chamber of Commerce and Industry, Inc., endorsed Resolution No. 005 series of 2020 requesting the RIATF-EID XII to Implement a Uniform Policy on the Entry and Exit of Essential Vehicles in the Region
- WHEREAS, upon thorough discussions and deliberations, the RIATF-EID XII member agencies agreed to issue relevant policies and come up with effective strategies that would address not only the threats of the virus in the region but also emerging concerns confronting the LGUs, agencies and the people of Region XII;

NOW, THEREFORE, BE IT RESOLVED, as it is hereby resolved, that the RIATF-EID XII approves the following Resolutions:

- 1. RESOLUTION CONCURRING THE DECLARATION OF 4 PROVINCES, HUC GENERAL SANTOS AND ICC COTABATO TO RETAIN ITS GCQ STATUS FROM JUNE 1-30, 2020 SUBJECT TO NIATF APPROVAL;
- 2. RESOLUTION ENDORSING THE "BALIK-TAHANAN PROGRAM" FOR LSIS OF REGION 12 FOR ITS ENHANCEMENT AND APPROVAL;
- 3. RESOLUTION REQUESTING RTF COVID-19 TO CONSIDER SETTING TIMELINES IN REPATRIATING LSIS;

- 8.9 DILG XII to coordinate with LGU-Kalamansig, Sultan Kudarat for APOR to enter their AOR without undergoing a 14-day quarantine; and
- 8.10 For each member of the Task Force to answer all questions and concerns when asked about IATF 12
