SUBJECT : REPORT OF LGUs FINANCIAL ASSISTANCE TO PNP/BFP/BJMP UNIFORMED BUREAUS UNDER THE DILG

DATE : 09 November 2011

Republic Act No. 7160 or the Local Government Code of 1991, in its general welfare clause under Section 16 states, among others, that Local Government Units (LGUs) shall *“exercise the powers expressly granted, those necessarily implied therefrom, as well as powers necessary, appropriate or incidental for its efficient and effective governance, and those which are essential to the promotion of the general welfare. Within their territorial jurisdictions, local government units shall ensure and support x x x maintain peace and order, and preserve the comfort and convenience of their inhabitant” (underscoring ours).*

In doing so, LGUs provide or donate lots, facilities and other financial/material assistance for uniformed bureaus under the Department of the Interior and Local Government.

In this regard, for purposes of transparency, accountability and in order to maintain inventory/accounting of fund support whether in kind, cash or lot donation given to these agencies (PNP/BFP/BJMP) and equipment on loan basis, may we be furnished with report(s) on this financial/material assistance following the attached format/matrix.



This will aid/help us in coming up with a policy on the accounting and rationalizing the allocation to the concerned operating units of the aforesaid uniformed bureaus.

The non-accounting/inventory of the support given by the LGUs has been the usual findings of the COA in their value for money and financial performance audit of the concerned units.

In this regard, all LGUs are hereby directed to submit to the DILG Central Office thru the Office of the Assistant Secretary for Finance and Comptrollership the required report(s) the soonest possible time.
