# A RESOLUTION APPROVING THE RESTRUCTURING OF THE RIATG-EID 12 TO RIATF 12 TO INCLUDE DBM XII, DENR XII, CHED XII, DEPED XII, DICT 12, DPWH XII AND DOF-BLGF XII AS ADDITIONAL MEMBERS IN ACCORDANCE WITH IATF RESOLUTION NO. 34 S. 2020

WHEREAS, pursuant to IATF Resolution No. 14, the Regional Inter-Agency Task Groups on Emerging Infectious Diseases (RIATG-EID) were organized in all regions being headed by the DOH with the following member agencies: DOLE XII, DSWD XII, DTI XII, DOT XII, PRO XII, AFP-PA (6th& 10th ID), DA XII, NEDA XII, DOST XII, DTI XII, PIA XII, PCG, DOTr-LTO XII and DOJ-PAO XII;

WHEREAS, on May 8, 2020, the IATF-EID issued Resolution No. 34 s. 2020 approving the Recommendation of the IATF Screening and Validation Committee for the

Regional Inter-Agency Task Force (RIATF) to be chaired by the Regional Director of the Department of the Interior and Local Government (DILG) and co-chaired by the Regional Director of Department of Health Centers for Health Development (DOH-CHD):

WHEREAS, the RIATF shall have the following roles and responsibilities, to wit:

- Regularly monitor performance across all sectors and develop appropriate policies or recommendations;
- Process appeals using same methodology, taking into consideration inputs from the provinces, cities, municipalities; and
- Provide concurrence to appeals as appropriate, and realign resources as necessary;

WHEREAS, to ensure continuity and convergence of efforts in addressing the COVID-19 pandemic of relevant government agencies in the region and to effectively implement the policies and directives issued by the IATF and other policy making bodies regarding the "New Normal" situation in the region, the Joint RIATF 12 deemed it necessary to retain the membership of the RIATG-EID 12 to the RTF 12 with the inclusion of the member agencies mentioned in IATF Resolution No. 34 s. 2020 thereby mirroring the membership of the National IATF:
