## **RESOLUTION NO. 2021-26C**

November 17, 2021

RESOLUTION DIRECTING THE BARANGAY COUNCILS OF REGION XII TO SUBMIT THEIR MONTHLY ACCOMPLISHMENTS IN COVID-19 VACCINATION PROGRAM TO THEIR RESPECTIVE LVOCs COPY FURNISHED RVOC AND RIATF-EID XII

- **WHEREAS,** as the country ramps up the implementation of the COVID-19 vaccination nationwide, the National Government is exerting all its efforts to ensure the swift administration of vaccines to the eligible population;
- WHEREAS, DILG Memorandum Circular No. 2021-057 sets the "Guidelines to Fast-Track COVID-19 Vaccination Rollout in local government units and for them to adopt strategies that will meet the vaccination objectives, reduce vaccine hesitancy and increase vaccine confidence of the people;
- **WHEREAS**, said DILG Memorandum Circular suggested strategies and best practices to hasten the implementation of National Vaccination Program and encouraged the adoption of "whole-of-government" and whole-of-community approaches."
- **WHEREAS,** the barangays, through its Punong Barangays are encouraged to augment its resources, workforce, infrastructure, and encourage volunteerism among its constituents and massive advocacy on vaccination;
- WHEREAS, there is a need to come up with a unified record of accomplishment in the COVID-19 vaccination program including the accomplishments of Barangay Councils in Region XII;
- **WHEREAS,** the Body recognizes the accomplishments of our Barangays in Region XII in their efforts in the COVID-19 vaccination drive;
- NOW THEREFORE, on motion of RD Macario D. Gonzaga of LTO XII and seconded by ARD Jerome S. Barranco of OCD XII; BE IT RESOLVED, as it is hereby RESOLVED, to direct the Barangay Councils of Region XII to submit their monthly accomplishments in COVID-19 Vaccination Program to their respective Local Vaccination Operation Centers (LVOCs) copy furnished Regional Vaccination Operations Center (RVOC) and RIATF-EID XII
- RESOLVED FURTHER, that a copy of this Resolution be forwarded to the IATF-EID, NTF COVID-19, and members of RIATF-EID XII and RTF-COVID-19 XII for their information. Same Resolution shall be forwarded to all Punong Barangays and Local Government Units of Region XII for their information and appropriate action.
