**RESOLUTION URGING THE LGUs OF REGION 12 AND PHILHEALTH TO FACILITATE
THE ACCREDITATION OF LGU-RUN TTMFs, INFIRMARIES OR
HOSPITALS TO AVAIL COVID-19 PACKAGE**

WHEREAS, DILG as early as February 6, 2020 has issued Memorandum Circular 2020-023 otherwise known as the Guide to Action Against the 2019 Novel Coronavirus Acute Respiratory Disease. One of the many roles and responsibilities stipulated in the directive is for the LGUs to identify and designate appropriate place that will serve as the Barangay Isolation Unit (BIU) for those who have travel history from areas with COVID-19 cases and are manifesting symptoms. The BIU must be an enclosed but well-ventilated structure with walls, windows and doors. It must be equipped with appropriate furniture and beds and with sufficient provision of electricity and running water, a kitchen, toilet and bath;

WHEREAS, DOH has released Department Memorandum No. 2020-0270-A on October 29, 2020 which sets the Guidelines in the Certification of LIGTAS COVID-19 Community Isolation Units. The directive sets the standards and requirements for LIGTAS COVID-19 Centers as to physical plant, human resources, equipment, supplies and other resources;

WHEREAS, PhilHealth Circular No. 2020-0018 dated July 10, 2020 sets the Guidelines on the COVID-19 Community Isolation Benefit Package. LIGTAS COVID-19 Centers and Level 1 hospitals which are managed by the LGU or national government linked to a PhilHealth accredited Level 2 or Level 3 referral hospital may avail the said package provided that they are certified by DOH and accredited by PhilHealth;


NOW, THEREFORE, on motion of RD Aristides Concepcion Tan of DOH-CHD XII and seconded by RD Teresita Socorro C. Ramos of NEDA XII; **BE IT RESOLVED**, as it is hereby resolved, to Urge the LGUs of Region 12 and PhilHealth to Facilitate


the Accreditation of LGU-Run TTMFs, Infirmaries or Hospitals to Avail COVID-19 Package;

RESOLVED FURTHER, that a copy of this Resolution be forwarded to the IATF-EID, NTF COVID-19 and PhilHealth for their information and support. The same copy shall be furnished to RIATF-EID XII and RTF COVID-19 XII members for their information, and all Local Government Units of Region XII for their immediate and appropriate action.


