RESOLUTION ENCOURAGING ALL DOCTORS TO VOLUNTEER IN THE IMPLEMENTATION OF VACCINATION PROGRAM

- WHEREAS, the IATF-MEID issued Resolution No. 95 dated January 21, 2021 approving the Philippine National Deployment and Vaccination Plan for COVID-19 Vaccines (NDVP). The plan adopts the whole-of-government and whole-of-society approach. As such, government agencies are enjoined to coordinate with the CSOs, private groups, media men and other stakeholders for the smooth implementation of the program;
- **WHEREAS,** the LGUs, being at the frontline of COVID-19 disaster response, are expected to fast track the implementation of vaccination program to ensure community herd immunity against the virus. In the course of managing the pandemic, LGUs encountered concerns on limited human resources to spearhead the inoculation process;
- **WHEREAS,** the Body acknowledges the Filipino value of volunteerism or *bayanihan spirit,* hence, in this time of adversity, they call the assistance of all medical practitioners to be engaged in the implementation of the vaccination program for the immediate healing and recovery of the country from COVID-19 pandemic;
- NOW, THEREFORE, on motion of RD Macario D. Gonzaga of LTO XII and jointly seconded by PSR Ronan Eugene C. Garcia of MEDAFC, RDC XII and ARD Jerome B. Barranco of OCD XII; BE IT RESOLVED, as it is hereby resolved, to Encourage all Doctors to Volunteer in the Implementation of Vaccination Program;
- **RESOLVED FURTHER,** that a copy of this Resolution be forwarded to the IATF-EID, NTF COVID-19, and all duly organized Medical Societies in Region XII for their information and support. The same copy shall be furnished to RIATF-EID XII and RTF COVID-19 XII members and all Local Government Units of Region XII for their information.
