RESOLUTION NO. 2021-14B

July 14, 2021

RESOLUTION REQUESTING THE NATIONAL GOVERNMENT AGENCIES OF REGION 12 TO IDENTIFY MEMBERS OF THEIR RESPECTIVE CONTACT TRACING TEAMS TO SUPPORT THE LGUs IN THEIR CONTACT TRACING EFFORTS AND FOR DOH-CHD XII AND DILG XII TO PROVIDE THE NEEDED CAPACITY INTERVENTION

WHEREAS, IATF-MEID has released Resolution No. 124 which classified the Province of Cotabato under Modified General Community Quarantine (MGCQ) while the remaining parts of the Region under General Community Quarantine (GCQ) effective July 1, 2021;

WHEREAS, DOH-CHD XII reported that as of June 13, 2021, the Region has a total of 24,111 confirmed cases of whom 20,276 have fully recovered, 766 deaths and 3,065 are currently under quarantine or confined in the referral hospitals. An average of 213 cases was recorded in a span of seven days;

WHEREAS, DOH has published a Workplace Handbook on COVID-19 Management and Prevention on September 30, 2020. It specifically requires the employer or the duly organized Occupation Safety and Health (OSH) Committee to initiate contact tracing in the workplace whenever there are employees identified either a suspect, probable or COVID-19 patient;

WHEREAS, DTI and DOLE Joint Memorandum Circular No. 20-04-A series of 2020 provides the following guidelines in the conduct of contact tracing among the workforce: employers shall ensure that close contacts undergo a 14-day mandatory quarantine; close contacts, while in 14-day quarantine, to report to their employer their health status; close contacts who remain asymptomatic for 14 days may return to work without need for a test; and employers to allow work-from-home (WFH) arrangements for the close contacts when feasible;

WHEREAS, the Body agreed that the national government offices should assist the LGUs in ensuring that all close contacts are identified and isolated. The efforts under

the Detect Strategy should be strengthened to prevent the spread of COVID-19 specially among the APORs;

NOW, THEREFORE, on motion of RD Aristides Concepcion Tan of DOH-CHD XII and seconded by ARD Rosie Javate of DPWH XII; **BE IT RESOLVED**, as it is hereby resolved, to Request the National Government Agencies of Region 12 to Identify Members of their Respective Contact Tracing Teams to Support the LGUs in its Contact Tracing Efforts and for DOH-CHD XII and DILG XII to Provide the Needed Capacity Intervention;

RESOLVED FURTHER, that a copy of this Resolution be forwarded to the IATF-EID, NTF COVID-19, and LGUs of Region XII for their information. The same copy shall be furnished to RIATF-EID XII and RTF COVID-19 XII members for their immediate and appropriate action.


