RESOLUTION NO. 2021-15C

July 28, 2021

RESOLUTION URGING ALL COASTAL LGUS OF REGION 12 TO ORGANIZE THEIR RESPECTIVE TASK FORCE DALAMPASIGAN TO SAFEGUARD ITS MARITIME BORDERS AGAINST COVID-19 CARRIERS OR SPREADERS OF DELTA VARIANT

- WHEREAS, IATF-MEID has released Resolution No. 127-A which classified the entire Region under General Community Quarantine (GCQ) effective July 15, 2021 until July 31, 2021;
- WHEREAS, DOH-CHD XII reported that as of July 27, 2021, the Region has a total of 26,722 confirmed cases of whom 23,279 have fully recovered, 869 deaths and 2,569 are currently under quarantine or confined in the referral hospitals. An average of 187 cases was recorded in a span of fourteen days;
- WHEREAS, a new strain of COVID-19 known as Delta variant or B.1.617.2 was detected in India on December, 2020. It then spread to other areas and now considered to be the dominant variant in US and Great Britain. The World Health Organization (WHO) has called the said version of the virus being the "fastest and fittest". Since it is considered to be highly contagious compared to other strains, medical experts fear that it will infect the unvaccinated population and will spike the cases in populous areas;
- WHEREAS, DOH has confirmed entry of sixteen (16) Delta variant cases of COVID-19 in the country on July 16, 2021. As of July 27, 2021, cases of Delta variant were recorded in Cagayan de Oro City; Gingoog City, Misamis Oriental and Talakag, Bukidnon of Region 10; and Tagum City, Davao del Norte of Region 11;
- **WHEREAS,** the vast waters of the Region has been the entry points of foreign nationals and local traders, and the meeting point of fisherfolks who may be carriers of Delta variant which is spreading in many areas of Southeast Asia;
- WHEREAS, the Body recommended that the stricter maritime control and visibility of local task forces among coastal LGUs will serve as a proactive measure to keep off the Delta variant in SOCSKSARGEN Region;

NOW, THEREFORE, on joint motion of RD Aristides Concepcion Tan of DOH-CHD XII and RD Teresita Socorro C. Ramos of NEDA XII and seconded by RD Servillano Santiago Lorenzo III of DOJ-PAO XII; BE IT RESOLVED, as it is hereby resolved, to Urge All Coastal LGUs of Region 12 to Organize Their Respective Task Force Dalampasigan to Safeguard its Maritime Borders against COVID-19 Carriers or Spreaders of Delta Variant;

RESOLVED FURTHER, that a copy of this Resolution be forwarded to the IATF-EID, and NTF COVID-19 for their information and support. The same copy shall be furnished to RIATF-EID XII and RTF COVID-19 XII members for their information, and all coastal Local Government Units of Region XII and Capt Rejard V Marfe of CGS SOCSARGEN for their immediate and appropriate action.
