RESOLUTION NO. 2020-022 July 22, 2020

POLICY GUIDELINES AND RECOMMENDATIONS RELATIVE TO THE MANAGEMENT OF CORONAVIRUS **DISEASE (COVID-19) SITUATION IN REGION 12**

- WHEREAS, the Inter-agency Task Force for the Management of Emerging Infectious Diseases (IATF-EID) issued Resolution No. 55-A on July 14, 2020 placing the entire SOCCSKSARGEN Region under Modified General Community Quarantine (MGCQ) until July 31, 2020. However, the Provinces of Cotabato, South Cotabato, Sultan Kudarat and the City of General Santos were classified as Medium Risk MGCO. It also provides that the National Task Force and the DILG shall implement strict lock down to high risk areas in line with the Zoning Containment Strategy, enforce minimum health standards and intensify tracing and quarantine of close contacts and isolation of confirmed cases among concerned LGUs;
- WHEREAS, DOH-CHD XII COVID-19 Tracker revealed that the Region, as of July 21, 2020, has one hundred seventy nine (179) confirmed patients, three of whom died, sixty eight (68) have fully recovered, and one hundred eight (108) are still on a quarantine. Among the active cases, ninety seven (97) or 90.65.% are ROFs and LSIs, nine have no travel history and one is still uncategorized;

- WHEREAS, DepEd Secretary Leonor M. Briones during the public briefing with the President on July 21, 2020 announced that limited face-to-face classes for K-12 children will be observed among low risk areas or those which are at least classified under MGCQ or in the transition phase between GCQ and the New Normal. Schools which shall implement the said scheme will be inspected and consent of the parents will be sought including the support of the concerned LGUs;
- WHEREAS, DILG Advisory dated June 22, 2020 which supports the IATF and NTF Memorandum Circular on the Application of the Zoning Containment Strategy for COVID-19 provides that the LGUs, through their Local Chief Executives, have the authority to determine and declare zoning classification and lockdown depending on preset parameters, including the existence of suspected, probable, or confirmed COVID-19 case. The authority maybe exercised immediately to ensure timely response, subject to the review and assessment of the RIATF and RTF;
- WHEREAS, RIATF-EID XII and RTF COVID-19, as the lead policy-making and implementing body for COVID-19 response in the Region, recognized the vital role of the LGUs and the Regional Line Agencies (RLAs) in institutionalizing the whole government approach in containing and preventing the spread of the infection;
- WHEREAS, during the Joint RIATF-EID XII and RTF COVID-19 Meeting, the Body discussed, strategized, and resolved emerging local issues and determined appropriate or future actions to avoid the further spreading of the virus;
- **NOW, THEREFORE, BE IT RESOLVED,** as it is hereby resolved, that the Joint RIATF-EID XII- RTF-COVID-19 approved the following Resolutions:
 - A. RESOLUTION CONCURRING THE REQUEST FOR LOCKDOWN IN SELECTED AREAS OF REGION XII SPECIFICALLY IN SITIO AWAL, BRGY. LAMBA, BANGA, SOUTH COTABATO FROM JULY 19-24, 2020; SITIO MISALAY, BRGY MALATAB, ANTIPAS, COTABATO FROM JULY 20-AUGUST 2, 2020; PORTION OF SITIO GAUNAN, SITIO MAGULING AND GUIAMAL COMPOUND ALONG SAYRE NATIONAL HIGHWAY, BRGY. MANARAPAN, AND CALICARAN RESIDENCE AT PUROK 7, BRGY. POBLACION CARMEN, PROVINCE OF COTABATO FROM JULY 21-28, 2020;
 - B. RESOLUTION REITERATING RIATF-EID XII-RTF COVID-19 XII RESOLUTION NO. 2020-020A AND REQUESTING CAAP NATIONAL OFFICE TO REQUIRE LSIS OF REGION XII TO PRESENT THEIR NEGATIVE RT-PCR TEST RESULT WITHIN 48 HOURS UPON BOARDING;
 - C. RESOLUTION COMMENDING DOST-XII FOR THE INITIATIVES UNDERTAKEN IN RESPONSE TO COVID-19;
 - D. RESOLUTION COMMENDING SULTAN KUDARAT PROVINCIAL SANGGUNIANG KABATAAN FEDERATION FOR THE INITIATIVES UNDERTAKEN IN RESPONSE TO COVID-19; AND
 - E. RESOLUTION SUPPORTING THE REGION-WIDE PILOT TESTS FOR THE DIFFERENT LEARNING DELIVERY MODALITIES OF DEPED 12
