RESOLUTION INDORSING TO THE IATF-EID THE REQUEST OF SULTAN KUDARAT PROVINCE FOR ITS CLASSIFICATION FROM MGCQ TO GCQ STATUS

WHEREAS, Per OMNIBUS GUIDELINES ON THE IMPLEMENTATION OF COMMUNITY QUARANTINE IN THE PHILIPPINES with Amendments as of July 16, 2020, the IATF approved the Implementation of the Modified Enhanced Community Quarantine

(MECQ) including the zoning concept, corresponding qualification, and its phased response or intervention;

As of August 19, 2020, Region XII is placed under Modified General Community Quarantine (MGCQ) status. Under the MGCQ status, LGUs of Region 12 shall strictly observed the following, to wit:

- Minimum public health standards shall be complied with at all times for the duration of the MGCQ;
- The movement of all persons shall be limited to accessing essential goods and services, for work in the offices or industries permitted to operate hereunder, and for other activities permitted under this Section. (As amended by Paragraph A(4)(a) of IATF Resolution No. 43, June 03, 2020);
- Mass gatherings such as but not limited to, movie screenings, concerts, sporting events, and other entertainment activities, religious services, and work conferences shall be allowed provided that participants shall be limited to fifty percent (50%) of the seating or venue capacity. (As amended by Paragraph A(4)(d) of IATF Resolution No. 43, June 03, 2020)

WHEREAS, for the period August 1, 2020 to August 18, 2020, the Region 12 recorded an increase of seventy nine (79) confirmed cases based on the DOH COVID -19 Tracker, as shown in data below:

Above data reflected that the Province of Sultan Kudarat ranks 3rd in total number of COVID-19 cases in the Region and recorded an increase of nineteen (19) COVID-19 cases during the period covered.

WHEREAS, on July 24, 2020, the NTF COVID 19 issued a Memorandum setting the parameters for the LGUs in their appeal for the classification under different levels of community quarantine;

The area most affected by the virus for the past 10 days is the Province of Sultan Kudarat, which recorded an additional 9 COVID cases from August 8-August 17, 2020. While contact tracing is on-going, the Provincial Government of Sultan Kudarat has requested the NIATF thru the RIATF-RTF COVID-19 to change its classification status from MGCQ to GCQ;

WHEREAS, upon careful evaluation of the Province's Containment Strategy and Data Analytics submitted to the RIATF-RTF COVID-19, and to avoid community transmission of the virus in the areas affected, the Body favourable recommend the request of the Province of Sultan Kudarat for its consideration;

NOW, THEREFORE, on motion of ARISTIDES CONCEPCION TAN, MD, REGIONAL DIRECTOR OF DOH-CHD XII and jointly seconded by TERESITA SOCCORO C. RAMOS, REGIONAL DIRECTOR OF NEDA XII and PSR RONAN E. GARCIA, MEDAFC- RDC XII; BE IT RESOLVED, AS IT IS HEREBY RESOLVED to Indorse to the National IATF-EID the Request of Sultan Kudarat Province for its Classification form MGCQ to GCQ Status;

RESOLVED FURTHER, that a copy of this Resolution be forwarded to the National IATF-EID and NTF COVID-19 for their information and or appropriate action. The same copy to be furnished to the members of the RIATF-EID XII & RTF COVID-19 for their information and prompt action.
