# RESOLUTION ENJOINING ALL GOVERNMENT AGENCIES AND LGUS OF REGION XII TO ENSURE THAT APPROPRIATE ENGINEERING CONTROL MEASURES ARE IMPLEMENTED IN ITS RESPECTIVE WORK PLACES TO CONTAIN THE SPREAD OF THE COVID-19 VIRUS

WHEREAS, the spread of COVID-19 continues unabated throughout the world;

- **WHEREAS**, SOCCSKSARGEN Region is not spared in this pandemic as shown by the increase in the cases of local transmission in some cities and municipalities;
- **WHEREAS**, the DOH has a nationwide campaign for the adoption by individual citizens of the minimum health standards through their B.I.D.A. campaign;
- **WHEREAS**, there is a need to intensify the prevention of COVID-19 in government offices, public transport conveyances, industrial and business establishments to supplement the DOH's B.I.D.A.;
- WHEREAS, SARS-COV-2 can be easily transmitted in closed spaces/ working environment;
- **WHEREAS**, engineering control measures reduce exposure to hazard without relying on worker behavior and can be cost effective;
- NOW, THEREFORE, on motion of TERESITA SOCCORO C. RAMOS, REGIONAL DIRECTOR OF NEDA XII and unanimously seconded by members of the task forces; BE IT RESOLVED, AS IT IS HEREBY RESOLVED to Enjoining All Government Agencies and LGUs of Region XII to Ensure that Appropriate Engineering Control Measures are Implemented in its Respective Work Places to Contain the Spread of the COVID-19 Virus and approved the following recommendations:
  - 1. All government offices, public transport conveyances, industrial and business establishments shall institute engineering control measures by:
    - a. Installing physical barriers such as plastic sneeze guards or plastic barricades with frames in:
      - a.1. Cashier counters in government and privates offices, supermarkets, department stores, banks, sari-sari and convenience stores (prototypes enclosed);
      - a.2. In between seats in barber shops, saloons and massage clinics;
      - a.3. In public conveyances such as multicabs, pedicabs and motorelas;
    - b. For business process outsourcing establishment/closed spaces
      - b.1. Installation of high efficiency air filters;
      - b.2. Increasing ventilation rates;

Examples: 1) Provision of exhaust fans; and

2) Provision of ceiling fans with ducting system that terminates outside.

c. Provision of directional floor making

Examples: 1) Keep Right Policy; and

2) Avoidance of crisscrossing.

- d. Provision of floormat with disinfectant in all entrances of the building;
- e. Provision of 4-faucet handwashing area in entrance/exit gates.

**RESOLVED FURTHER**, that a copy of this Resolution be forwarded to National IATF- EID, NTF COVID-19, Provincial Governors, City Mayors of Region XII for their consideration and appropriate action. The same copy to be furnished to the members of the RIATF- EID XII & RITF COVID-19 for their information and appropriate action.
