RESOLUTION NO. 2021-16C

RESOLUTION ENJOINING LGUS OF REGION 12 TO REVISIT THEIR CRISIS ACTION PLANS FOR THE ONSET OF THE DELTA VARIANT

- WHEREAS, IATF-MEID has released Resolution No. 130-A which classified the entire Region under General Community Quarantine (GCQ) effective August 1, 2021 until August 31, 2021;
- WHEREAS, DOH-CHD XII reported that as of August 10, 2021, the Region has a total of 30,017 confirmed cases of whom 25,944 have fully recovered, 972 deaths and 3,096 are currently under quarantine or confined in the referral hospitals. An average of 236 cases was recorded in a span of fourteen days;
- WHEREAS, a new strain of COVID-19 known as Delta variant or B.1.617.2 was detected in India on December, 2020. It spread to other areas and now considered to be the dominant variant in the US and Great Britain. The World Health Organization (WHO) has called the said version of the virus as the "fastest and fittest". Since it is considered to be highly contagious compared to other strains, medical experts fear that it will infect the unvaccinated population and will spike the cases in populous areas;
- WHEREAS, DOH has confirmed entry of sixteen (16) Delta variant cases of COVID-19 in the country on July 16, 2021. As of August 10, 2021, DOH-CHD XII shared that that the Region has one COVID-19 patient found to have contracted with the Delta variant;
- **WHEREAS**, the Body recommended that the LGUs, being at the frontline of COVID-19 response, should revisit their crisis action plans to prepare and prevent the possible transmission of COVID-19 Delta variant among the residents of the Region;
- NOW, THEREFORE, on motion of ARD Jerome B. Barranco of OCD XII, and seconded by RD Teresita Socorro C. Ramos of NEDA XII; BE IT RESOLVED, as it is hereby



resolved, to Enjoin LGUs of Region 12 to Revisit their Crisis Action Plans for the Onset of the Delta Variant;

RESOLVED FURTHER, that a copy of this Resolution be forwarded to the IATF-EID, NTF COVID-19 and members of RIATF EID XII and RTF COVID-19 XII for their information and support. The same copy shall be furnished to all Local Government Units of Region 12 for their information and immediate action.
