RESOLUTION NO. 2021-16D

August 11, 2021

RESOLUTION REQUESTING THE NATIONAL TASK FORCE FOR COVID-19 THROUGH SECRETARY CARLITO GALVEZ, JR., CHIEF IMPLEMENTER AND VACCINE CZAR, TO ALLOCATE JANNSEN VACCINE TO REGION 12

- WHEREAS, IATF-MEID has released Resolution No. 130-A which classified the entire Region under General Community Quarantine (GCQ) effective August 1, 2021 until August 31, 2021;
- WHEREAS, DOH-CHD XII reported that as of August 10, 2021, the Region has a total of 30,017 confirmed cases of whom 25,944 have fully recovered, 972 deaths and 3,096 are currently under quarantine or confined in the referral hospitals. An average of 236 cases was recorded in a span of fourteen days. Further, a total of 61,550 individuals for A1 group, 90,826 individuals for A2 group, 143,879 individuals for A3 group and 300 individuals for A4 group were fully vaccinated in partnership with LGUs;
- WHEREAS, FDA has issued Emergency Use Authorization to Johnson and Johnson's Janssen as COVID-19 vaccine. The vaccine is ideally to be administered to those ages 18 years old and above in one dose and can be stored for three months in a freezer with temperature ranging from 2°C to 8°C;
- **WHEREAS**, with the limited cold chain storage of Region 12, the Body has noted that the unique specifications of the Jannsen COVID-19 vaccines is strategic for the storage capacity and needs of the LGUs of SOCSKSARGEN considering its frequency of dosage does not demand huge storage facilities;
- NOW, THEREFORE, on motion of RD Teresita Socorro C. Ramos of NEDA XII, RD Macario Gonzaga of LTO XII, and Atty. Servillano Santiago Lorenzo III of DOJ-PAO XII, and seconded by RD Aristides Concepcion Tan of DOH-CHD XII; BE IT RESOLVED, as it is hereby resolved, to Request the National Task Force for COVID-19 through Secretary Carlito Galvez, Jr., Chief Implementer and Vaccine Czar, to Allocate Jannsen Vaccine to Region 12;



RESOLVED FURTHER, that a copy of this Resolution be forwarded to the IATF-EID and NTF COVID-19 for their information and consideration. The same copy shall be furnished to all members of the RIATF-EID XII and RTF COVID-19 XII and all LGUs of Region 12 for their information and reference.
