**RESOLUTION REQUESTING THE NATIONAL TASK FORCE FOR COVID-19 TO CONSIDER
DILG PERSONNEL TO BE INCLUDED IN THE PRIORITY LIST OF EMPLOYEES OF
REGIONAL GOVERNMENT AGENCIES TO BE INOCULATED**

WHEREAS, IATF-MEID has released Resolution No. 130-A which classified the entire Region under General Community Quarantine (GCQ) effective August 1, 2021 until August 31, 2021;

WHEREAS, DOH-CHD XII reported that as of August 10, 2021, the Region has a total of 30,017 confirmed cases of whom 25,944 have fully recovered, 972 deaths and 3,096 are currently under quarantine or confined in the referral hospitals. An average of 236 cases was recorded in a span of fourteen days;

WHEREAS, the IATF for the Management of Emerging Infectious Disease issued Resolution No. 95 dated January 21, 2021 approving the Philippine National Deployment and Vaccination Plan for COVID-19 Vaccines (NDVP). The plan lays down the prioritization of eligible population for vaccination which should be followed to strategically maintain public health and safety until herd immunity is achieved;

WHEREAS, during the Joint of the RTF- COVID -19 and RIATF on August 11, 2021, it was requested by Dr. Aristides Concepcion Tan that the Regional Vaccination Operation Center XII, through the local government units, is set to inoculate the A4 sector including the employees of the priority list Agencies from the Regional Offices of DOTr, DAR, DFA, DOT, DA, BOC, BI, AFP, PCG, BFP, NBI, CHED, DOLE, PNP, and DepEd this August, 2021;

WHEREAS, the DILG, **considering the nature of its current tasks** in the management of COVID-19, DILG personnel are highly vulnerable to contacting the virus. The daily engagement of DILG personnel to LGUs on various technical interventions cannot be over emphasized.


WHEREAS, the Body affirmed that DILG officers, should have been considered as another priority employees of the RLAs to be vaccinated in the A4 sector;


NOW, THEREFORE, on motion of Gov. Steve C. Solon of Sarangani, and seconded by RD Teresita Socorro C. Ramos of NEDA XII; **BE IT RESOLVED**, as it is hereby resolved, to Request the National Task Force for COVID-19 to Consider DILG Personnel to be Included in the Priority List of Employees of Government Agencies to be Inoculated;

RESOLVED FURTHER, that a copy of this Resolution be forwarded to the IATF-EID and NTF COVID-19 for their information and consideration. The same copy shall be furnished to all members and the National COVID-19 Vaccination Operations Center (NVOC) for their information.


