**RESOLUTION NO. 2021-17A**

August 25, 2021

**RESOLUTION ENJOINING THE LGUs TO ENSURE THE FUNCTIONALITY AND LIVABILITY OF THEIR TEMPORARY TREATMENT AND MONITORING FACILITY (TTMF)**

**WHEREAS**, DILG as early as February 6, 2020 issued Memorandum Circular 2020-023 otherwise known as the Guide to Action Against the 2019 Novel Coronavirus Acute Respiratory Disease. One of the many roles and responsibilities stipulated in the directive is for the LGUs to identify and designate appropriate place/s that will serve as the Barangay Isolation Unit (BIU) for those who have travel history from areas with COVID-19 cases and are manifesting symptoms. The BIU must be an enclosed but well-ventilated structure with walls, windows and doors. It must be equipped with appropriate furniture and beds and with sufficient provision of electricity and running water, a kitchen, toilet and bath;

**WHEREAS**, DOH has released Department Memorandum No. 2020-0270-A on October 29, 2020 which sets the Guidelines in the Certification of LIGTAS COVID-19 Community Isolation Units. The directive sets the standard requirements for LIGTAS COVID-19 Centers as to physical plant, human resources, equipment, supplies and other resources. Among the required facilities and amenities include the following: two-hour proximity to higher level facilities, water closets, urinals, lavatories, shower rooms, laundry area, electricity, potable water source, sewer line, fan ventilation, adequate lighting and health care waste system;

**WHEREAS**, DOH-CHD XII reported that as of August 24, 2021, the Region has a total of 368 TTMFs with 10,472 bed capacity, however the said facilities are mostly day care centers, school buildings and old buildings of the barangays with inadequate amenities;

**WHEREAS**, the Body acknowledges that the conducive environment of TTMFs contributes to the immediate healing and recovery of COVID-19 patients and their close contacts;





**NOW, THEREFORE**, on motion of RD Aristides Concepcion Tan of DOH-CHD XII, and seconded by ARD Jerome B. Barranco; **BE IT RESOLVED**, as it is hereby resolved, to Enjoin the LGUs to Ensure the Functionality and Livability of their Temporary Treatment and Monitoring Facility (TTMF);

**RESOLVED FURTHER**, that a copy of this Resolution be forwarded to the IATF-EID and NTF COVID-19 for their information and support. The same copy shall be furnished to all members of the RIATF-EIDX II and RTF-COVID-19 XII for their information and all Local Government Units of Region 12 for their information and appropriate action.


