## RESOLUTION NO. 2021-17B

August 25, 2021

## RESOLUTION ENJOINING THE LGUS TO INCLUDE IN THEIR DEVOLUTION TRANSITION PLANS THE CONSTUCTION AND MAINTENANCE OF THEIR TEMPORARY TREATMENT AND MONITORING FACILITIES (TTMFs)

- WHEREAS, the Supreme Court decision in the consolidated cases of Cong. Hermilando Mandanas et al. vs Executive Secretary Paquito Ochoa, Jr. et al and Hon. Enrique Garcia, Jr. vs Executive Secretary Paquito Ochoa, Jr. et al dated July 3, 2018 has clarified the basis for the computation of local government shares and ordered the national government to include all collections of national taxes in the computation of the base amount for the just share of the LGUs;
- **WHEREAS**, Executive Order (EO) No. 138, s. 2021 has ordered the full devolution of functions, services, and facilities by the national government to the LGUs not later than the end of FY 2024;
- WHEREAS, DILG and DBM has issued Joint Memorandum Circular No. 2021-1 dated August 11, 2021 which provides the guidelines on the preparation of Devolution Transition Plans (DTPs) of LGUs in support of full devolution under EO No. 138;
- **WHEREAS,** DOH-CHD XII reported that as of August 24, 2021, the Region has a total of 368 TTMFs with 10,472 bed capacity. However, the said facilities are mostly day care centers, school buildings and old buildings of the barangays;
- **WHEREAS,** with the COVID-19 pandemic, the Body recommends that the LGUs should prioritize the construction and maintenance of their TTMFs in order to provide comfort and livable environment to patients and prevent the spread of the virus in the communities;
- **NOW, THEREFORE,** on motion of RD Aristides Concepcion Tan of DOH-CHD XII, and seconded by ARD Jerome B. Barranco; **BE IT RESOLVED,** as it is hereby resolved, to Enjoin the LGUs to Include in their Devolution Transition Plans the Construction and Maintenance of their Temporary Treatment and Monitoring Facilities (TTMFs);

**RESOLVED FURTHER,** that a copy of this Resolution be forwarded to the IATF-EID and NTF COVID-19 for their information and support. The same copy shall be furnished to all members of the RIATF-EIDX II and RTF-COVID-19 XII for their information and all Local Government Units of Region 12 for their information and appropriate action.
