**RESOLUTION COMMENDING THE LOCAL GOVERNMENT UNIT OF MALUNGON,
SARANGANI FOR THEIR BEST PRACTICE IN THE IMPLEMENTATION
OF SAFETY SEAL PROGRAM**

WHEREAS, IATF-MEID has released Resolution No. 87 dated December 3, 2020 adopting the implementation of the Safety Seal Certification Program which requires all establishments (i.e. government offices, private companies, hotels, and business establishments) and public transportation units to adopt the Safety Seal;

WHEREAS, DOLE, DOH, DILG, DOT and DTI issued Joint Memorandum Circular No. 21-01 which sets the guidelines of the Safety Seal Certification Program. It delineates the coverage of the agencies involved as issuing authorities of the Safety Seal;

WHEREAS, DILG issued Memorandum Circular No. 53 dated May 12, 2021 which provides the implementing guidelines of the Safety Seal Certification Program for the Department and the LGUs as Issuing Authorities. In compliance to the said directive, Hon. Maria Theresa D. Constantino issued Executive Order No. 24 series of 2021 which established the Safety Seal Certification Program in the Municipality of Malungon;

WHEREAS, based on DILG's data, LGU-Malungon is the first among the LGUs of Region 12 to organize its Inspection and Certification Team, and to inspect and issue Safety Seals to all of its component barangays and select establishments operating in the LGU. Its Inspection and Certification Team is also currently conducting ocular visits to business establishments with pending application;

WHEREAS, the Body recognized that the effort of LGU-Malungon is worthy of emulation by other LGUs especially in enforcing the minimum health protocols while the local economy is gradually opening;


NOW, THEREFORE, on motion of RD Aristides Concepcion Tan of DOH-CHD XII, and seconded by RD Macario D. Gonzaga of LTO XII; **BE IT RESOLVED**, as it is hereby resolved, to Commend the Local Government Unit of Malungon, Sarangani for their Best Practice in the Implementation of Safety Seal Program;

RESOLVED FURTHER, that a copy of this Resolution be forwarded to all members of the RIATF-EIDX II and RTF-COVID-19 XII and Hon. Maria Theresa D. Constantino of the Municipality of Malungon for their information.


