RESOLUTION NO. 2021-20B

October 6, 2021

RESOLUTION ENJOINING ALL LOCAL GOVERNMENT UNITS OF REGION XII TO TAP THE CIVIL SOCIETY ORGANIZATIONS (CSOs), PEOPLE'S ORGANIZATIONS (POs), ACADEME, AND LOCAL RESEARCH INSTITUTES (LRIs) TO SUPPORT AND ASSIST THE LOCAL VACCINATION TEAMS IN THE VACCINATION ROLLOUT PROGRAM

WHEREAS, the IATF Resolution No. 141-A has classified the entire Region XII under General Community Quarantine (GCQ) with heightened restrictions until October 31, 2021. Further, the Omnibus Guidelines on the Implementation of

Community Quarantine in the Philippines dated September 23, 2021, *as updated*, provided for the minimum protocols to be observed in areas under the GCQ status requiring the strict implementation of the following: minimum public health standards shall be complied with at all times xxx; and the movement of all persons shall be limited to accessing goods and services from permitted establishments, for work in such establishments, or for such other activities xxx;

WHEREAS, DOH-CHD XII reported that as of October 5, 2021, the Region has 52,059 total cumulative confirmed cases with 4,327 (8%) active cases, 45,997 (88%) have fully recovered, 1,726 (3.32%) deaths, and 11,335 are currently under quarantine or confined in the referral hospitals. A total of 4,318 cases was recorded in a span of two weeks from September 22 to October 5, 2021;

WHEREAS, DOH-CHD XII presented updates on COVID-19 Vaccination Roll-out in Region XII during the Joint RIATF-EID XII – RTF on COVID XII Meeting on October 6, 2021, highlighting the following:

1. A1 Priority Group - 80,032 (First Dose); 71,708 (2nd Dose)
2. A1.8 Priority Group - 1,864 (First Dose); 3,115 (2nd Dose)
3. A1.9 Priority Group - 18,779 (First Dose); 17,679 (2nd Dose)
4. A1 + FHW
Priority Group - 3,885 (First Dose); 5,243 (2nd Dose)
5. A2 Priority Group - 97,005 (First Dose); 125,490 (2nd Dose)
6. A3 Priority Group - 174,587 (First Dose); 263,271 (2nd Dose)
7. A3 Expanded
Priority Group - 156 (First Dose); 8 (2nd Dose)
8. A4 Priority Group - 182,416 (First Dose); 53,300 (2nd Dose)
9. A5 Priority Group - 6,390 (First Dose); 7 (2nd Dose)

WHEREAS, as of October 6, 2021, the region has a total of 1,271,524 vaccine allocation, and 1,104,935 are fully-vaccinated individuals with a consumption rate of 86.90%;

WHEREAS, recommendations for efficient vaccination roll-out were presented during the RIATF-EID XII – RTF on COVID-19 Technical Working Group Virtual Meeting held on September 24, 2021, which include the participation of civil society organizations, peoples' organizations, academe, and local research institutes as potential partners of local vaccination teams in communication, advocacy, and other vaccination roll-out demand generation activities;

WHEREAS, the Body recognizes the collaboration of local government units, government agencies/instrumentalities, and other partners to contribute to the efficiency and success of vaccination program and to promote the overall health and safety of the populace;


NOW THEREFORE, on motion of RD Aristedes Conception Tan, MD of DOH XII and seconded by RD Alimbzar Asum of DICT Mindanao Cluster; **BE IT RESOLVED**, as it is hereby **RESOLVED**, to enjoin all local government units of Region XII to tap the civil society

organizations, people's organizations, academe, and local research institutes to support and assist the local vaccination teams in the Vaccination Rollout Program;

RESOLVED FURTHER, that a copy of this Resolution be forwarded to the IATF-EID, NTF COVID-19, and members of RIATF-EID XII and RTF-COVID-19 XII for their information and support. The same copy shall be furnished to all Local Government Units of Region XII for their information and appropriate action.


