RESOLUTION NO. 2021-22A

RESOLUTION APPROVING THE IMMERSION PROGRAM OF THE RIATF-EID XII AND RTF ON COVID-19 XII AS A STRATEGY IN THE CAMPAIGN FOR MASSIVE COVID-19 VACCINATION PROGRAM IN REGION XII

WHEREAS, the IATF-MEID issued Resolution No. 95 dated January 21, 2021, approving the Philippine National Deployment and Vaccination Plan for COVID-19 Vaccines (NDVP). The plan adopts the whole-of-government and whole-of-society approach where all members of the society and government are encouraged to participate and take action to achieve the collective goal of achieving herd immunity in the country;

WHEREAS, DILG issued Memorandum Circular 2021-07 dated January 18, 2021 enjoining the LGUs to prepare their vaccination plans. Specifically, the LGUs are mandated to prepare their risk communication plan, master list of priority of eligible vaccine population, list of designated vaccine centers, cold chain storages and other logistical requirements; master list of human resources and personnel for the program; and reorganized EOC dedicated for vaccine concerns, among others;

WHEREAS, while the government leads in the deployment of vaccines and implementation in the vaccination program, private sector, CSOs and other multi-stakeholders are encouraged to collaborate and work closely with the government sector to ensure a unified and coordinated vaccination implementation; Hence, the success of the vaccination implementation in the Region is shared responsibility;

WHEREAS, during the Joint RIATF-EID XII and RTF on COVID-19 Meeting held on November 3, 2021, DOH-CHD XII reported that Region XII still has a low turnout of vaccinated individuals;

NOW THEREFORE, on motion of RD Akmad Usman of DBM XII and seconded by RD Aristides Tan of DOH-CHD XII; **BE IT RESOLVED**, as it is hereby **RESOLVED**, to approve the Immersion Program of the RIATF-EID XII and RTF on COVID-19 XII as a strategy in the campaign for Massive COVID-19 Vaccination Program in Region XII.

RESOLVED FURTHER, that a copy of this Resolution be forwarded to the IATF-EID, NTF COVID-19 and members of RIATF-EID XII and RTF-COVID-19 XII for their information. The same copy shall also be furnished to the members of the TWG on Immersion Program for information and appropriate action and all local government units of Region XII.
