RESOLUTION ADOPTING THE ROLL-OUT STRATEGY PROPOSAL FOR THE NATIONAL COVID-19 VACCINATION DAY

- WHEREAS, as the country ramps up the implementation of the COVID-19 vaccination nationwide, the National Government facilitated vaccination activities and expedited vaccination of individuals with zero dose by devoting three (3) days solely for vaccination activities nationwide;
- WHEREAS, the National COVID-19 Vaccination Days dubbed as "Bayanihan, Bakanuhan" is set on November 29, 30 and December 1, 2021 which utilizes the "bayanihan" concept where communities unite, work, and cooperate together to achieve the goal of herd immunity in the entire country, as well as mobilizing all stakeholders, people and logistics to facilitate the COVID-19 vaccination to 15 million individuals in three (3) days;
- WHEREAS, during the Joint Meeting of the RIATF-EID XII and RTF on COVID-19, DOH-CHD XII presented the Roll-Out Strategy in the 3-day National COVID-19 Vaccination Days;
- WHEREAS, Region XII targets 311,894 per day with a total of 935,688 3-day consolidated target; thereby policies, communication and demand generation, standard vaccination operational process, structure and logistics are prepared before and after the national vaccination day implementation set by the National Vaccination Operations Center (NVOC);
- WHEREAS, with the strong collaboration of local government units, National Government Agencies, and stakeholders, Region XII have stepped up beyond the guidance that had been provided by the national government, thus, formulating a "Regional COVID-19 Vaccination Day Immersion Program" in the least performing local government units across the Region for the 3-day national vaccination days. This is part of Region 12's Regional Strategy in the Management of COVID-19 Response;
- WHEREAS, said "Immersion Program" was approved through RIATF Resolution No. 2021-22A on November 3, 2021 during its Joint RIATF-EID XII and RTF on COVID-19 XII Meeting as a strategy to increase vaccination coverage in the Region;
- NOW THEREFORE, on motion of Atty. Felix S. Alicer of DENR-XII and seconded by RD Macario D. Gonzaga of LTO XII; BE IT RESOLVED, as it is hereby RESOLVED, to adopt the Roll-out Strategy Proposal for the National COVID-19 Vaccination Day;

RESOLVED FURTHER, that a copy of this Resolution be forwarded to the IATF-EID, NTF COVID-19, and members of RIATF-EID XII and RTF-COVID-19 XII. Same copy shall also be provided to all local government units of Region 12 for their information and reference.
