RESOLUTION NO. 2021-33 December 9, 2021

RESOLUTION ENJOINING ALL LOCAL GOVERNMENT UNITS OF REGION XII TO PROVIDE THE NECESSARY SUPPORT TO THE NATIONAL VACCINATION DAYS ROUND 2 ON DECEMBER 15, 16, AND 17, 2021



- **WHEREAS,** Section 15 Article II of the 1987 Constitution provides that the State shall protect and promote the right to health of the people and instill health consciousness among them;
- WHEREAS, on September 10, 2021, the President issued Proclamation No. 1218 series of 2021, further extending the period of the State of Calamity throughout the Philippines until September 12, 2022, unless earlier lifted as circumstances may warrant or extended due to the public's failure to comply with minimum health protocols and sudden spike of new COVID-19 cases in the country;
- **WHEREAS,** the continued implementation of proactive measures must be put in place to minimize the spike of COVID-19 cases in the country, and one of which is massive vaccination among eligible population;
- WHEREAS DILG Memorandum Circular No. 2021-128 dated November 23, 2021 re: Bayanihan, Bakunahan: National COVID-19 Vaccination Days. Item 4.3.1.9 of MC, directs our Local Government Units to mobilize barangay officials and barangay-based institutions to support and assist in the conduct of vaccination;
- WHEREAS all local government units through their Local Chief Executive are directed to harmonize their efforts, strengthen the information and dissemination campaign and may implement incentive programs to encourage their constituencies to be vaccinated and to raise their confidence in the COVID-19 vaccines. They are also encouraged to provide the Barangay and SK Officials with the necessary assistance and support for them to effectively and efficiently perform their respective roles and tasks;
- WHEREAS the Body recognizes that the effective implementation of National COVID-19 Vaccination Programs can be attributed on the measures being undertaken by local government units from vaccine supplies management to vaccine administration and demand generation with whole-of-government and wholeof-community approach;
- NOW THEREFORE, on motion of RD Akmad J. Usman of DBM XII and seconded by ARD Jerome S. Barranco of OCD XII; BE IT RESOLVED, as it is hereby RESOLVED, to request local government units of Region XII to provide the necessary support to the National Vaccination Days Round 2 on December 15, 16, and 17, 2021;
- **RESOLVED FURTHER**, that a copy of this Resolution be forwarded to the IATF-EID, NTF COVID-19, and members of RIATF-EID XII and RTF-COVID-19 XII for their information. Same Resolution be forwarded to all members of the RIATF-EID XII and RTF-COVID-19 XII for their information.
