RESOLUTION NO. 2022-02

January 12, 2022

RESOLUTION ENJOINING LOCAL GOVERNMENT UNITS OF REGION XII TO SUPPORT THE REGIONAL VACCINATION DAYS ON JANUARY 24-26, 2022 AND FEBRUARY 7-9, 2022 IN ORDER TO RAMP-UP THE VACCINATION RATE OF REGION XII

WHEREAS, Section 15 Article II of the 1987 Constitution provides that the State shall protect and promote the right to health of the people and instill health

consciousness among them;

WHEREAS, on September 10, 2021, the President issued Proclamation No. 1218 series of

2021, further extending the period of the State of Calamity throughout the Philippines until September 12, 2022, unless earlier lifted as circumstances may warrant or extended due to the public's failure to comply with minimum health

protocols and sudden spike of new COVID-19 cases in the country;

WHEREAS, during the 1st Meeting of the Joint RIATF-EID XII and RTF XII for 2022, the DOH-

CHD XII reported that, as of January 11, 2022, SOCCSKSARGEN Region has a target population of **3,490,115**. Of these target population, only **1,815,476** or **(52.01%)** are fully vaccinated, around **1,213,403 (34.77%)** are still unvaccinated (partially vaccinated, missed second doses), and only **71,279**

received their booster doses;

















WHEREAS,

at the start of the year, cases of COVID-19 are increasing particularly in the National Capitol Region arise. While the SOCCSKSARGEN Region is still under Alert Level 2, vigilance and pro-activeness must be done and a "Bayanihan" approach is needed.

WHEREAS,

the implementation of **Bayanihan**, **Bakunahan**: **SOCCSKSARGEN Regional COVID-19 Vaccination Days** on January 24 to January 26, 2022 (Round 1) and February 7 to 9, 2022 (Round 2) replicating the nation's approach during the conduct of the National Vaccination Days in the last quarter of 2021 can be one of the best strategies to inoculate the target eligible population;

WHEREAS,

as provided in the National Deployment and Vaccination Plan (NDVP), local government units thru their LCEs should operationalize the structure and functions of the LVOC and integrate them in their existing systems for COVID-19 response operations and intensify vaccination campaign to all eligible population, the soonest possible time.

WHEREAS,

DILG Memorandum Circular No. 2021-128 dated November 23, 2021 re: Bayanihan, Bakunahan: National COVID-19 Vaccination Days. Item 4.3.1.9 of MC enjoins Punong Barangays to support the implementation of vaccination by providing assistance in ensuring that the Minimum Public Health Protocols (MHPS) are observed in the vaccination sites, ensure that public order and security in the vaccination sites are maintained, mobilize BHERTs and Sangguniang Kabataan Officials to provide necessary support and assistance in the vaccination sites within their respective LGUs in coordination with their Punong Barangays and C/Municipal IATF;

WHEREAS,

the same DILG MC also enjoins Provincial Governors and City/Municipal Mayors need to strengthen the information and dissemination campaign and may implement incentive programs to encourage their constituencies to be vaccinated and to raise their confidence in the COVID-19 vaccines. They are also encouraged to provide the Barangay and SK Officials with the necessary assistance and support for them to effectively and efficiently perform their respective roles and tasks;

WHEREAS.

the Body recognizes that the effective implementation of National COVID-19 Vaccination Programs can be achieve through the forging of unity, cooperation, and collaboration of the Filipino people by maximizing the whole-of-government and whole-of-community;

NOW THEREFORE, on motion of RD Akmad J. Usman of DBM XII and seconded by ARD Jerome S. Barranco of OCD XII; BE IT RESOLVED, as it is hereby RESOLVED, to ENJOIN THE LOCAL GOVERNMENT UNITS OF REGION XII TO SUPPORT THE REGIONAL VACCINATION DAYS ON JANUARY 24-26, 2022 AND FEBRUARY 7-9, 2022 IN ORDER TO RAMP-UP THE VACCINATION RATE OF REGION XII.
