RESOLUTION NO. 2021-12F

RESOLUTION REQUESTING THE PHILHEALTH TO FAST TRACK THE PAYMENT OF THE COVID-19 RELATED EXPENSES INCURRED BY PROVINCIAL GOVERNMENT OF SARANGANI FOR CATERING TO THE MODERATE, HIGH AND SEVERE CASES IN ITS LGU-RUN HOSPITALS NOTWITHSTANDING THE LEVEL/S OF ACCREDITATION

WHEREAS, DOH Department Memorandum No. 2020-0142 dated March 23, 2020 prescribed that only licensed Level 2 and Level 3 hospitals, whether private or government, shall be eligible to become COVID-19 referral hospitals. The said hospitals shall prioritize management of confirmed COVID-19 cases especially those with comorbidity, elderly, and pregnant women; accept referred confirmed COVID-19 patients from other hospitals; collect specimens and facilitate testing of patients for COVID-19; and ensure the adequacy of hospital infrastructure, human resource complement, and essential supplies for COVID-19 cases;

WHEREAS, PhilHealth Circular No. 2020-009 enumerates the benefit packages for inpatient care of probable and confirmed COVID-19 developing severe illness/outcomes;

WHEREAS, Joint RIATF-EID XII and RTF-COVID-19 XII during its regular meeting on June 16, 2021 has adopted Resolution No. 2021-12D entitled, Resolution Requesting IATF-MEID to Allow All Capable Infirmaries and Level 1 Hospitals to Manage Moderate to Severe COVID-19 Patients in the Region;



WHEREAS, the increasing number of COVID-19 patients in Sarangani Province necessitates the LGU-run hospitals to confine some of their patients with moderate to severe conditions despite its Level I accreditation because the COVID-19 referral hospitals are fully occupied;

NOW, THEREFORE, on motion of Gov. Steve C. Solon of Sarangani Province and jointly seconded by RD Macario D. Gonzaga of LTO XII and RD Teresita Socorro C. Ramos of NEDA XII; BE IT RESOLVED, as it is hereby resolved, to Request the Philhealth to Fast Track the Payment of the COVID-19 Related Expenses Incurred by Provincial Government of Sarangani for Catering to the Moderate, High and Severe Cases in Its LGU-Run Hospitals Notwithstanding the Level/s of Accreditation;

RESOLVED FURTHER, that a copy of this Resolution be forwarded to the IATF-EID and NTF COVID-19 for their information. The same copy shall be furnished to RIATF-EID XII and RTF COVID-19 XII members and the Provincial Governor of Sarangani for their information.
