RESOLUTION NO. 2020-025-A

August 12, 2020

RESOLUTION IMPOSING AN INTER-REGIONAL LOCKDOWN FOR NON-ESSENTIAL TRAVELS FROM AUGUST 15-31, 2020 AND FOR THE PNP XII TO IMPLEMENT STRICTER BORDER CONTROL **MEASURES**

WHEREAS, Per OMNIBUS GUIDELINES ON THE IMPLEMENTATION OF COMMUNITY QUARANTINE IN THE PHILIPPINES with Amendments as of July 16, 2020, the IATF approved the Implementation of the Modified Enhanced Community Quarantine (MECQ) including the zoning concept, corresponding qualification, and its phased response or intervention;

As of August 12, 2020, for areas placed under MECQ, GCQ, MGCQ status, the following provisions shall be strictly observed, to wit:

- Minimum public health standards shall be complied with at all times for the duration of the MGCQ;
- The movement of all persons in areas placed under MECQ, GCQ & MGCQ shall be limited to accessing essential goods and services, for work in the offices or industries permitted to operate hereunder, and for other activities permitted under this Section. (As amended by Paragraph A(4)(a) of IATF Resolution No. 43, June 03, 2020);
- WHEREAS, one of the concerns of the COVID-19 Task Forces at all levels is the movement of Authorized Persons Outside Residences or APORS. There were observations that APORS seemed to disregard observance of the minimum health and LGU protocols while passing through Region 12 borders or in going out of their residences and or engaging in their respective work assignments;
- WHEREAS, per DOH COVID -19 Tracker, the region recorded a total of **328 cases as of August 5**, **2020**, which is equivalent to an average of **4 cases per day** for the month of August 2020;

The increase in the COVID-19 cases has been attributed to several factors, such as but not limited to:

- Non-observance of the DOH's and LGUs' Minimum Health Standards and Protocols;
- Allowing the movement of persons except for leisure in areas placed under GCQ and MGCQ; and
- Permitting the road, rail, maritime, and aviation sectors of public transportation, and private transportation in areas placed under the GCQ and MGCQ;
- WHEREAS, with the increasing number of COVID-19 cases in the region, the RIATF-EID and RTF COVID-19 Task Forces recommended for an Inter-Regional Lockdown for non-essential travels and for the PNP XII to implement stricter border control measures;
- NOW, THEREFORE, on motion of ATTY. SERVILLANO SANTIAGO LORENZO III of PAO XII and duly seconded by HON. ATTY. FRANCES CYNTHIA GUIANI-SAYADI, City Mayor of Cotabato City; BE IT RESOLVED, AS IT IS HEREBY RESOLVED to Impose an Inter-Regional Lockdown for Non-Essential Travels from August 15-31, 2020 and For the PNP XII to Implement Stricter Border Control Measures;
- **RESOLVED FURTHER,** that a copy of this Resolution be forwarded to the National IATF-EID and NTF COVID-19 for their information and favourable consideration. To PNP-PRO XII for their information, immediate and prompt action. The same copy to be furnished to the members of the RIATF-EID XII & RTF COVID-19, Provincial Governors, City and Municipal Mayors of Region XII for their information and or appropriate action.
