RESOLUTION NO. 2020-038-A

November 25, 2020

A RESOLUTION REQUESTING THE DIRECT AND IMMEDIATE INTERVENTION OF THE IATF-EID AND NTF AGAINST COVID-19 IN THE TURN-OVER BY THE PROVINCIAL GOVERNMENT OF SOUTH COTABATO OF THE SOCCSKSARGEN GENERAL HOSPITAL IN FAVOR OF THE DEPARTMENT OF HEALTH – CENTER FOR HEALTH DEVELOPMENT XII

WHEREAS, on October 26, 2018, President Duterte signed Republic Act No. 11102 entitled “An Act Establishing the SOCCSKSARGEN General Hospital in the Municipality of Surallah, Province of South Cotabato, and Appropriating Funds Therefor”;

WHEREAS, in the FY 2020 General Appropriations Act, the amount of P49.625 Million has been included for the operationalization of the SOCCSKSARGEN General Hospital (SGH);

WHEREAS, on January 06, 2020, the Department of Budget and Management (DBM) has released a NOSCA for the 144 plantilla positions approved for the SGH in CY 2020;

WHEREAS, on February 20, 2020, the RDC XII passed a Joint Advisory Committee and Executive Committee Resolution No. 15, series of 2020 appealing to the Provincial Government of South Cotabato to transfer the Supervision of Upper Valley Community Hospital also known as the SGH to DOH-CHD XII, following the enactment of RA No. 11102;

WHEREAS, during the September 23, 2020 RIATF-EID XII and RTF XII Against COVID-19 Meeting, it was agreed that a Facilitation Team composed of the Regional Directors of DILG XII, NEDA XII, DBM XII, and PAO XII shall assist the parties in the turn-over of the SGH to DOH-CHD XII;

WHEREAS, on October 06, 2020, in a meeting called by Governor Reynaldo Tamayo, Jr., it was agreed that there is a need to finalize or revisit the Transition Plan output which was crafted on February 19-21, 2020 workshop;

WHEREAS, on October 07, 2020, the Transition Teams of the DOH-CHD XII and the Provincial Government of South Cotabato convened for the revisiting of the Transition Plan and finalized the same with the assistance of the Facilitation Team, with the turn-over set on June 31, 2021;

WHEREAS, on October 15, 2020, NTF Against COVID-19 Chief Implementer Carlito Galvez, Jr., during the Joint RTF XII Against COVID-19 and RIATF-EID XII Meeting provided guidance on the turn-over timeline, specifically, that the turn-over be facilitated by 2020 in order for Region XII to have a share in the funds allocated under the Bayanihan Grant 2;

WHEREAS, acting upon the guidance of Secretary Galvez, the Facilitation Team through the DILG XII convened the Transition Teams on October 20, 2020 to finalize and/or adjust the timelines which was set on December 15, 2020, with the signing of the Transition Plan set on October 24, 2020;

WHEREAS, on October 23, 2020, the DILG XII was informed by Governor Tamayo that the signing of the Transition Plan scheduled on October 24, 2020 will be deferred to a later date due to the localized lockdown being implemented at the Municipality of Tupi, South Cotabato and the Governor is also undergoing 14-day mandatory quarantine;

WHEREAS, in a Joint RIATF-EID XII and RTF XII Against COVID-19 Meeting held on October 28, 2020, the members expressed its concern on the timeline for the turn-over since it may deprive Region XII of additional resources for the hospital due to the delay in the turn-over;

WHEREAS, on November 09, 2020, the Inventory Committee composed of DOH-CHD XII and Provincial Government of South Cotabato convened for the conduct of the Inventory of the Properties at the SGH in accordance with what was reflected in the Transition Plan;

WHEREAS, the matching of the existing plantilla personnel of the Upper Valley Community Hospital (UVCH) was undertaken, with eleven (11) of the nineteen (19) regular employees of UVCH manifesting their intent to be absorbed to the SGH;

WHEREAS, during the November 25, 2020 Joint RIATF-EID XII and RTF XII Against COVID-19 Meeting, the members were informed that the request for funding by the DOH-CHD XII to the DBM XII cannot be favorably processed pending its official turn-over;

NOW, WHEREFORE, upon motion of RD TERESITA SOCORRO RAMOS, NEDA XII and seconded by RD MACARIO GONZAGA, LTO XII, RESOLVE as it is hereby **RESOLVED** to **REQUEST THE DIRECT AND IMMEDIATE INTERVENTION OF IATF- EID AND NTF AGAINST COVID-19 IN THE TURN-OVER BY THE PROVINCIAL GOVERNMENT OF SOUTH COTABATO OF THE SOCCSKSARGEN GENERAL HOSPITAL IN FAVOR OF THE DEPARTMENT OF HEALTH – CENTER FOR HEALTH DEVELOPMENT XII;**

RESOLVE FURTHER that a copy of the said resolution be forwarded to IATF-EID and NTF Against COVID-19 for their immediate and appropriate action, and all the RIATF-EID XII and RTF XII Against COVID-19 members for their information;
