**RESOLUTION NO. 2020-038**

November 25, 2020

**POLICY GUIDELINES AND RECOMMENDATIONS RELATIVE TO THE MANAGEMENT OF  
CORONAVIRUS DISEASE (COVID-19) SITUATION IN REGION 12**

**WHEREAS**, per Omnibus Guidelines on the Implementation of Community Quarantine in the Philippines dated October 22, 2020, the IATF approved the minimum protocols to be observed by areas under the Modified General Community Quarantine status. It specifically requires the strict implementation of the following:

- *Minimum public health standards shall be complied with at all times for the duration of MGCQ; and*
- *The movement of all persons in areas under MGCQ shall be limited to accessing essential goods and services, for work in the offices or industries permitted to operate xxx.*

**WHEREAS**, DOH-CHD XII reported that as of November 24, 2020, the Region has a total of 3,738 confirmed cases of whom 3,129 have fully recovered, 128 deaths and 480 are currently under quarantine or confined in the referral hospitals. In a matter of fourteen days, a total of 486 cases or an average of 35 cases per day was recorded;

**WHEREAS**, NTF Against COVID-19 Order No. 2020-02 entitled, “Operational Guidelines on the Management of Locally Stranded Individuals” mandates the LGUs to organize the Sub-Task Group on Management of Returning Overseas Filipinos and Locally Stranded Individuals (STG on Management of ROFs and LSIs) under their Local COVID-19 Task Forces. The STG is tasked to facilitate the repatriation of ROFs and LSIs especially in transporting them from the various entry points of Mindanao to LGUs’ respective isolation areas 24/7 a week;

**WHEREAS**, the Joint Task Force of RIATF-EID XII and RTF-COVID-19 XII recognize the hardwork and dedicated services of the STG members on the Management of ROFs and LSIs; hence they deserved a break and celebrate the holidays

with their families. On October 28, 2020 meeting, the Task Forces approved two resolutions, to wit:

- *Resolution Favorably Indorsing to NTF-COVID-19 and IATF-EID the Request of Surallah, South Cotabato for the Moratorium of the Entry of LSIs on December 24, 25, 31, 2020 and January 1, 2021; and*
- *Resolution Requesting the NTF-COVID-19 and IATF-EID to Allow the Moratorium of the Entry of LSIs to Region 12 LGUs on December 24, 25, 31, 2020 and January 1, 2021*

**WHEREAS**, the Local COVID-19 Task Force of Surallah during its meeting on November 16, 2020 passed Resolution No. 05 s. 2020 entitled, "Resolution Requesting a Moratorium for the Return of Locally Stranded Individuals (LSIs) and Returning Overseas Filipino (ROFs) on December 20, 2020 to January 3, 2020". The moratorium will serve as an opportunity for the frontliners to spend time with their respective families and the much-needed time to rest. It will also allow the LGU to conduct cleaning and disinfection activities specially in isolation facilities and to schedule the repair and maintenance of vehicles used in transporting LSIs and ROFs;

**WHEREAS**, the Joint Task Force of RIATF-EID XII and RTF-COVID-19, facilitated a number of activities for the immediate turn-over of the SOCCSKSARGEN General Hospital (SGH) from the Province of South Cotabato to the Department of Health-Center for Health Development (DOH-CHD XII). Among its significant initiatives were the creation of the Facilitation Team composed of DILG, NEDA, DBM, and PAO on September 23, 2020, for the Transition Teams of DOH-CHD XII and Provincial Government of South Cotabato to meet on October 7, 2020 and October 20, 2020, and assisted in a meeting of the Inventory Committee of the properties of the SGH on November 9, 2020. However, despite its efforts and constant coordination, the two parties are yet to sign a transition plan and usufruct agreement for the formal turn-over of the said health facility;

**WHEREAS**, the Local Government Units are mandated to be on the frontline of disaster response and lead in the overall management of COVID-19 response operations within their AORs. Despite the overwhelming concerns brought by the pandemic, LGUs must still endeavor to deliver the basic health services to its constituents;

**WHEREAS**, during the 25<sup>th</sup> Joint RIATF-EID XII and RTF COVID-19 Meeting, the Body discussed, strategized, and resolved emerging local issues and determined appropriate future actions to avoid the further spreading of the virus;

**NOW, THEREFORE, BE IT RESOLVED**, as it is hereby resolved, that the Joint RIATF-EID XII- RTF-COVID-19 approved the following Resolutions:

- A. RESOLUTION REQUESTING THE DIRECT AND IMMEDIATE INTERVENTION OF IATF-EID AND NTF AGAINST COVID-19 IN THE TURN-OVER OF SOCCSKSARGEN GENERAL HOSPITAL (SGH) IN


- FAVOR OF THE DEPARTMENT OF HEALTH-CENTER FOR HEALTH DEVELOPMENT XII;
- B. RESOLUTION APPROVING THE REQUEST FOR MORATORIUM OF THE ENTRY OF LSIs TO SURALLAH, SOUTH COTABATO FROM DECEMBER 20, 2020 TO JANUARY 3, 2021; and
- C. RESOLUTION ENJOINING LGUs OF REGION XII TO CONTINUOUSLY PROVIDE HEALTH SERVICES TO THEIR CONSTITUENTS AMIDST THE COVID-19 PANDEMIC.

**RESOLVED FURTHER**, that a copy of this Resolution be forwarded to the IATF-EID and NTF COVID-19 for information and support. The same copy to be furnished to the Provincial Governors, City and Municipal Mayors of Region XII, members of RIATF-EID XII & RTF COVID-19 for their information and/or appropriate action.


