RESOLUTION NO. 2020-40

December 23, 2020

RESOLUTION ALLOWING THE REQUEST OF TESDA 12 TO CONDUCT A LECTURE ON FIRE AND EARTHQUAKE DRILLS ON JANUARY, 2021 IN KORONADAL CITY BY THE BUREAU OF FIRE PROTECTION XII

WHEREAS, per Omnibus Guidelines on the Implementation of Community Quarantine in the Philippines dated November 19, 2020, the IATF approved the minimum protocols to be observed by areas under the Modified General Community Quarantine status. It specifically requires the strict implementation of the following:

- Minimum public health standards shall be complied with at all times for the duration of MGCQ;
- The movement of all persons in areas under MGCQ shall be limited to accessing essential goods and services, for work in the offices or industries permitted to operate xxx; and
- Mass gatherings such as but not limited to movie screenings, concerts, sporting events, and other entertainment activities, religious services, and work conferences shall be allowed provided that participants shall be limited to the 50% of the seating or venue capacity;

WHEREAS, DOH-CHD XII reported that as of December 22, 2020, the Region has a total of 4,453 confirmed cases of whom 4,018 have fully recovered, 157 deaths and 277 are currently under quarantine or confined in the referral hospitals. In a matter of fourteen days, a total of 317 cases or an average of 23 cases per day was recorded;



- WHEREAS, with the transfer of TESDA XII to its new office building at Prime Regional Center, Carpenter Hill, City of Koronadal, it is deemed necessary to conduct a lecture on fire and earthquake drills to its personnel by BFP XII. This is to assess their existing evacuation plan and other disaster preparedness protocols to ensure the safety and resilience of the office;
- WHEREAS, during the 27th Joint RIATF-EID XII and RTF COVID-19 XII Meeting, the Body supports the activity of TESDA XII as it is essential in developing the culture of preparedness and resilience, subject to necessary health and safety protocols in mass gatherings related to work conferences;
- NOW, THEREFORE, on motion of PSR Ronan Eugene C. Garcia of RDC XII-MEDAFC and seconded by RD Minda C. Morante of OCD XII; BE IT RESOLVED, as it is hereby resolved, to Allow the Request of TESDA XII to Conduct a Lecture on Fire and Earthquake Drills on January, 2021 in Koronadal City by the Bureau of Fire Protection XII;
- **RESOLVED FURTHER,** that a copy of this Resolution be forwarded to TESDA XII, BFP XII, and all members of RIATF-EID XII and RTF COVID-19 XII, for their information.
