# POLICY GUIDELINES AND RECOMMENDATIONS RELATIVE TO THE MANAGEMENT OF CORONAVIRUS DISEASE (COVID-19) SITUATION IN REGION 12

WHEREAS, per Omnibus Guidelines on the Implementation of Community Quarantine in the Philippines dated January 21, 2021, the IATF approved the minimum protocols to be observed by areas under the Modified General Community Quarantine status requiring the strict implementation of the following: minimum public health standards shall be complied with at all times xxx; the movement of all persons in areas under MGCQ shall be limited to accessing essential goods and services, for work in the offices or industries permitted to operate xxx; and mass gatherings such as but not limited to, movie screenings, concerts, sporting events, and other entertainment activities, religious services and work conferences shall be allowed provided that participants shall be limited to 50% of the seating or venue capacity;

WHEREAS, DOH-CHD XII reported that as of February 9, 2021, the Region has a total of 5,010 confirmed cases of whom 4,282 have fully recovered, 180 deaths



and 547 are currently under quarantine or confined in the referral hospitals. A total of 561 cases was added in a span of fourteen days or an average of 41 cases per day;

- WHEREAS, the national government recognizes the vital role of the LGUs to play in the success of the National Vaccination Program. It is a national endeavor which seeks to utilize a whole-of-government and whole-of-society approach;
- WHEREAS, the IATF for the Management of Emerging Infectious Disease issued Resolution No. 95 dated January 21, 2021 approving the Philippine National Deployment and Vaccination Plan for COVID-19 Vaccines (NDVP). It established the National and Regional COVID-19 Vaccination Operation Center which is expected to be mirrored by the LGUs for easy and efficient implementation of the vaccination program. The Local VOCs shall be composed of Planning, Campaign Management and Technical Team; Cold Chain and Logistics Team; Coordination Team; Vaccine Safety, Surveillance and Response Team; and Communications, Advocacy and Partnership Team;
- WHEREAS, the vaccination deployment requires end-to-end supply chain and logistic systems ensuring an effective vaccine storage, handling, and stock management, and rigorous temperature control in the cold chain. Relatedly, the LGUs must ready their systems and logistics to ensure the uninterrupted availability of quality vaccines from manufacturer or DOH-CHD to service-delivery point and vaccination location;
- WHEREAS, DILG issued Memorandum Circular 2021-07 dated January 18, 2021 enjoining the LGUs to prepare their vaccination plans. Specifically, the LGUs are mandated to prepare their risk communication plan, masterlist of priority of eligible vaccinee population, list of designated vaccine centers, cold chain storages and other logistical requirements; master list of human resources and personnel for the program; reorganized EOC dedicated for vaccine concerns, among others;
- **WHEREAS,** the LGUs, being at the frontline of COVID-19 disaster response, are expected to promote and ensure the safety and health of their communities;
- **WHEREAS,** during the 30<sup>th</sup> Joint RIATF-EID XII and RTF COVID-19 XII Meeting, the Body discussed, strategized, and resolved emerging local issues and determined appropriate future actions to avoid the further spreading of the virus;

**NOW, THEREFORE, BE IT RESOLVED,** as it is hereby resolved, that the Joint RIATF-EID XII- RTF-COVID-19 XII approved the following Resolutions:

- A. RESOLUTION ENJOINING LGUS TO SUPPORT THE ESTABLISHMENT OF A LOCAL VACCINATION OPERATION CENTER WITH APPROPRIATE/ADEQUATE STORAGE FACILITY; AND
- B. RESOLUTION ENJOINING LCEs OF REGION 12 TO FULLY SUPPORT AND IMPLEMENT THEIR APPROVED VACCINATION PLAN

RESOLVED FURTHER, that a copy of this Resolution be forwarded to the IATF-EID and NTF COVID-19 for information and support. The same copy to be furnished to the Provincial Governors, City and Municipal Mayors of Region XII for their information and immediate appropriate action, and members of RIATF-EID XII & RTF COVID-19 XII for their information and/or reference.
