RESOLUTION NO. 2021-05

**RESOLUTION REQUESTING DTI 12, DOLE 12 AND PNP 12 TO ISSUE A JOINT
ADVISORY TO ALL ESTABLISHMENTS IN REGION 12 TO SUSTAIN
THE STRICT OBSERVANCE OF HEALTH PROTOCOLS**

WHEREAS, the Omnibus Guidelines on the Implementation of Community Quarantine in the Philippines dated February 18, 2021 approved by the IATF provided for the minimum protocols to be observed in areas under the Modified General Community Quarantine status requiring the strict implementation of the following: minimum public health standards shall be complied with at all times xxx; the movement of all persons in areas under MGCQ shall be limited to accessing essential goods and services, for work in the offices or industries permitted to operate xxx; and any person below 15 years old, those who are over 65 years old, those with immunodeficiency, comorbidity, or other health risks, and pregnant women shall be required to remain in their residences at all times xxx;

WHEREAS, the same Guidelines provides that all permitted establishments and activities under Categories I, II, and III are allowed to operate at full capacity while 50% venue capacity shall be observed among barber shops, salons, dine-in restaurants, fast food and food retails establishments in areas under MGCQ;

WHEREAS, DOH-CHD XII reported that as of March 23, 2021, the Region has a total of 5,961 confirmed cases of whom 5,538 have fully recovered, 216 deaths

and 205 are currently under quarantine or confined in the referral hospitals. A total of 138 cases was recorded in a span of seven days or an average of 20 cases per day;

WHEREAS, DTI and DOLE Interim Guidelines on Workplace Prevention and Control of COVID-19 mandates the establishments to ensure safety and health of the workers in their workstations. Establishments are enjoined to comply with the minimum public health standards such as wearing of face masks and face shields, physical distancing and frequent disinfection, among others. The same directive requires the DTI and DOLE to monitor the compliance of the establishments and to extend necessary assistance and technical support to all workplaces, employers and workers;


WHEREAS, during the meeting of the Joint RIATF-EID XII and RTF-COVID 19, other members raised the concern that some private establishments relaxed their protocols which may cause sudden spike of COVID-19 cases, hence, requires reiteration and monitoring of minimum health protocols from these agencies;


NOW, THEREFORE, on motion of RD Teresita Soccoro C. Ramos of NEDA XII and seconded by RD Macario D. Gonzaga of LTO XII; **BE IT RESOLVED**, as it is hereby resolved, to Request DTI 12, DOLE 12, and PRO 12 to Issue a Joint Advisory to All Establishments in Region 12 to Sustain the Strict Observance of Health Protocols;

RESOLVED FURTHER, that a copy of this Resolution be forwarded to the IATF-EID, NTF COVID-19, RIATF-EID XII and RTF COVID-19 XII members for their information. The same copy to be furnished to DTI 12, DOLE 12, and PRO 12 for their information and appropriate action.


