### **RESOLUTION NO. 2021-07**

April 7, 2021

## POLICY GUIDELINES AND RECOMMENDATIONS RELATIVE TO THE MANAGEMENT OF CORONAVIRUS DISEASE (COVID-19) SITUATION IN REGION 12

WHEREAS, the IATF Resolution No. 107-A has classified the entire Region XII under Modified General Community Quarantine (MGCQ) from April 1 to April 30, 2021. Further, the Omnibus Guidelines on the Implementation of Community Quarantine in the Philippines provided for the minimum protocols to be observed in areas under the MGCQ status requiring the strict implementation of the following: minimum public health standards shall be complied with at all times xxx; and the movement of all persons shall be limited to accessing essential goods and services, for work in the offices or industries permitted to operate xxx;

WHEREAS, DOH-CHD XII reported that as of April 6, 2021, the Region has a total of 6,276 confirmed cases of whom 5,768 have fully recovered, 227 deaths and 279 are currently under quarantine or confined in the referral hospitals. A total of 185 cases was recorded in a span of seven days or an average of 27 cases per day;

- WHEREAS, as of April 6, 2021, DOH-CHD XII with the assistance of the LGUs, has inoculated a total of 43,781 individuals for the first dose of AstraZeneca and Sinovac vaccines, and 6,829 individuals for the second dose of Sinovac vaccine;
- WHEREAS, DILG Memorandum Circular No. 2021-19 dated February 17, 2021 enjoins the LGUs to organize their Local Vaccination Operations Center, to undertake social mobilization, advocacy and behavioral change communication activities and to implement the demand generation playbook such as the BIDA Solusyon PLUS;
- WHEREAS, IATF-EID Resolution No. 101 dated February 26, 2021 provides that testing shall not be mandatory for travelers except if the LGU of destination will require testing as a requirement prior to travel which shall be limited to RT-PCR, and no traveler shall be required to undergo quarantine unless they exhibit symptoms upon arrival at the LGU of destination;
- **WHEREAS,** the GenSan International Airport serves as the entry point of returning residents and ROFs alike to Region XII and other adjacent Regions. For the month of March, the airport has catered a total of 5,292 returning residents or an average of 171 individuals per day;
- WHEREAS, on February 26, 2021, the IATF-EID has adopted the Safe, Swift, and Smart Passage (S-PaSS) Travel Management System of DOST VI to serve as the institutionalized one-stop-shop application and communication for travelers. The LGUs, specifically the Provinces, HUCs and ICCs are encouraged to designate focal persons for its implementation;
- **WHEREAS,** during the 34<sup>th</sup> Joint RIATF-EID XII and RTF COVID-19 XII Meeting, the Body discussed, strategized, and resolved emerging local issues and determined appropriate or future actions to avoid the further spreading of the virus;
- **NOW, THEREFORE, BE IT RESOLVED,** as it is hereby resolved, that the Joint RIATF-EID XII- RTF-COVID-19 XII approved the following Resolutions:
  - A. RESOLUTION REQUESTING THE NGAs WITH HEALTH PERSONNEL TO ASSIST THE VACCINATION TEAMS OF REGION 12 LGUs;
  - B. RESOLUTION ENJOINING THE LGUS OF REGION 12 TO SPEARHEAD MORE AGGRESSIVE AND CONSISTENT IEC STRATEGIES ON COVID-19 VACCINATION TO GENERATE PUBLIC AWARENESS AND SUPPORT TO THE NATIONAL GOVERNMENT'S NATIONAL VACCINATION PROGRAM;
  - C. RESOLUTION ENJOINING ALL BUSINESS ESTABLISHMENTS IN REGION 12 TO CONSISTENTLY IMPLEMENT THE JOINT DTI-



- DOLE MEMORANDUM CIRCULAR NO. 2020-04 AND 04-A AND TO INSTITUTE A PUBLIC ADDRESS MECHANISM TO BE PLAYED IN THE VICINITY TO CONTINUOUSLY REMIND THE CLIENTS TO OBSERVE STRICTLY THE HEALTH PROTOCOLS;
- D. RESOLUTION REQUESTING IATF-EID TO APPROVE THE LOCAL GOVERNMENT UNITS' REQUEST TO IMPOSE SEVEN DAY MANDATORY QUARANTINE FOR ALL RETURNING RESIDENTS REGARDLESS OF THEIR POINT OF ORIGINS;
- E. RESOLUTION REQUESTING IATF-EID TO TEMPORARILY SUSPEND THE INBOUND COMMERCIAL FLIGHTS OF GENSAN INTERNATIONAL AIRPORT WHILE NCR AND ITS NEIGHBORING LGUS ARE ON ECQ UNTIL TWO WEEKS AFTER THE LIFTING THEREOF;
- F. RESOLUTION ENJOINING THE LGUS OF REGION 12 TO ADOPT AND IMPLEMENT THE SAFE, SWIFT AND SMART PASSAGE (S-PASS)

The same copy to be furnished to the Provincial Governors, City and Municipal Mayors of Region XII, and members of RIATF-EID XII & RTF COVID-19 XII for their information and/or appropriate action.
